Following discussion, it was moved by Chair Cervantes and seconded by Vice Chair Perry to refer to City Council staff recommendation to consider the Human Relations Commission's suggestions (1) for recognizing groups and causes which do not have an established commemorative flag by issuing Proclamations, lighting up the Grier Pavilion in associated colors, adding the groups and causes to the City's Cultural Holidays and Celebratory Months calendar, holding student poster art contests, and adding Riverside TV programming during the corresponding recognition Month; and (2) to expanding the list of groups and causes for recognition which do not have commemorative flags, consisting of Dr. Martin Luther King Day, Asian American and Pacific Islander Heritage Month, Hispanic/Lantinx Heritage Month, Indigenous Peoples Day, and Native American Heritage Month to include Human Trafficking Awareness Day, Developmental Disabilities Awareness Month, Lunar New Year, Deaf Awareness Week, Mental Health Awareness Month, Black Balloon Day, and National Poverty in America Awareness Month. The motion carried unanimously.
