## RECITALS

WHEREAS, the City and Contractor entered into that certain Parking Management Services Agreement dated December 14, 2021 ("Agreement"); and

WHEREAS, the City and Contractor wish to allow for Contractor's additional use of an available portion of the building located at 3780 Market Street, Riverside, California for office space; and

WHEREAS, Contractor provides Parking Management Services in accordance with Parking Rate and Hour Schedule Resolution attached to RFP No. 2083 as Exhibit "F." The Parking Rate and Hour Schedule Resolution is subject to amendment by City Council. City and Contractor agree that Contractor will continue to provide Parking Management Services consistent with the City Council Parking Rate and Hour Schedule Resolution No. 23978, as may be amended from time to time; and

WHEREAS, changes to parking programs, rates, and hours of operation over the last three years lead to increased expenses to the City; and

WHEREAS, the Agreement is set to expire on December 30, 2024; and

WHEREAS, the City is satisfied with the Contractor's performance; and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement by two (2) additional years through December 31, 2026, with additional compensation in the amount not to exceed Seven Million Eight Hundred Forty-Seven Thousand One Hundred Fifty Two Dollars (\$7,847,152.00), for the extended term of the Agreement.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 2, Term, is hereby amended in its entirety to read:
- "2. Term. This Agreement shall be in effect for a term of five (5) years beginning January 1, 2022, through December 31, 2026, unless otherwise terminated pursuant to the provisions herein."
- 2. Section 3, Compensation/Payment, is hereby amended to increase the compensation in the amount of Seven Million Eight Hundred Forty-Seven Thousand One Hundred Fifty Two Dollars (\$7,847,152.00), for the extended term of the Agreement.
- 3. Section 4.7 of Exhibit "A," Office Space, is hereby amended to include the following:

"Contractor will also have the use of a portion of the building located at 3780 Market Street, Riverside, California, consisting of approximately 2,325 square feet as office space. Such use is terminable concurrent with this Parking Management Services Agreement."

- 4. Exhibit "B," Compensation, is hereby revised and replaced in its entirety with Exhibit "B-1," attached hereto and incorporated herein by this reference.
- 5. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
