ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 2.04.010 OF THE RIVERSIDE MUNICIPAL CODE UPDATING THE REGULAR MEETING SCHEDULE OF THE CITY COUNCIL.

The City Council of the City of Riverside does ordain as follows:

<u>Section 1</u>: Section 2.04.010 of the Riverside Municipal Code is hereby amended as follows:

"The regular meetings of the Mayor and City Council shall be held on the first four Tuesdays of each month starting at the approximate hour of 1:00 p.m. or 3:00 p.m., which time is subject to change. Evening sessions shall start at the approximate hour of 6:15 p.m. There shall be no meeting on the fifth Tuesday of the month. During the months of July, August, and September there will be two meetings per month on the first and third Tuesdays. For the months of April, June, and October, meetings shall occur on the second, third, and fourth Tuesday of the month."

<u>Section 2</u>: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
