SUBJECT: AMEND RIVERSIDE MUNICIPAL CODE CHAPTER 2.04 TO AMEND CITY

**COUNCIL MEETING FREQUENCY - ORDINANCE** 

## ISSUE:

Amend Riverside Municipal Code Section 2.04.010 to provide for City Council regular meetings on the first four Tuesdays of each month, except that no City Council meeting on the fifth Tuesday of the month, City Council meetings only on the first and third Tuesdays of July, August, and September, and City Council meetings only on the second, third, and fourth Tuesdays for the months of April, June, and October, and afternoon sessions starting at 1:00 p.m. or 3 p.m. Evening sessions will continue to start at the approximate hour of 6:15 p.m.

### **RECOMMENDATION:**

That the City Council introduce and subsequently adopt an ordinance amending Section 2.04.010 of the Riverside Municipal Code to update the regular meeting schedule of the City Council to regular meetings on the first four Tuesdays of each month, except that no City Council meeting on the fifth Tuesday of the month, City Council meetings only on the first and third Tuesdays of July, August, and September, and City Council meetings only on the second, third, and fourth Tuesdays for the months of April, June, and October, and afternoon sessions starting at 1:00 p.m. or 3 p.m., with evening sessions continuing to start at the approximate hour of 6:15 p.m.

#### **DISCUSSION:**

On January 16, 2024, the City Council adopted Resolution No. 24076 establishing Rules of Procedure and Order of Business including the City Council meeting schedule with regular meetings on the first four Tuesdays of each month, no City Council meeting on the fifth Tuesday of the month, City Council meetings on the first and third Tuesdays of July, August, and September, and City Council meetings on the second, third, and fourth Tuesdays for the months of April, June, and October, afternoon sessions starting at 1:00 p.m. or 3 p.m., and evening sessions starting at the approximate hour of 6:15 p.m..

The ordinance amending Riverside Municipal Code Section 2.04.010 is in accordance with Resolution No. 24076 amending the City Council Rules of Procedure and Order of Business to reflect the revised meeting schedule.

#### STRATEGIC PLAN ALIGNMENT:

- Sustainability & Resiliency This item ensures sustainability through ongoing evaluation
  of City Council Rules of Procedure and Order of Business to allow for adaptation to meet
  the changing needs of the community.
