4	PROGRAM ADMINISTERED THROUGH THE STATE OF CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT AND
5	AUTHORIZING THE EXECUTION OF NECESSARY GRANT DOCUMENTS BY THE CITY MANAGER, OR DESIGNEE.

7	WHEREAS, the State of California Department of Housing and Community Development (the
8	"Grantor") has invited public agencies, including the City of Riverside ("City"), to submit applications
9	to the Grantor for the Prohousing Incentive Program Round 2 ("Grant Program") via the program
10	guidelines dated January 23, 2024; and
11	WHEREAS, in response to the program guidelines, the City desires to apply to the Grantor
12	for, and receive an allocation of, grant funds; and
13	WHEREAS, the City has an active housing production program that strives to provide
14	residential units for all income types of municipal residents; and
15	WHEREAS, on August 22, 2023, the City was notified by the Grantor that it had been
16	designated as a "Prohousing Designated Jurisdiction"; and
17	WHEREAS, the City has determined that it is in its best interests to submit an application for
18	grant funds to facilitate future housing development that serves low to moderate income residents; and
19	WHEREAS, the City shall submit an application to the Grantor to participate in the Grant
20	Program and for an allocation of funds not to exceed Two Million Dollars (\$2,000,000) ("Grant
21	Award") for projects that accelerate housing production, create equitable and sustainable communities,
22	and dismantle exclusionary land use policies.; and
23	WHEREAS, the City is familiar with the terms, conditions and limitations of any such grant;
24	and
25	WHEREAS, the City is willing and able to conform to each of the terms, conditions, and
26	limitations imposed upon any such grant to the City; and
27	WHEREAS, the Grantor must approve said application and will require the City to execute a
28	Funding Agreement and other necessary documents upon approval.
