We would support a one time rate increase to reflect current annual expenditures and needs





As a small business owner of the property located at 7575 Jurupa Avenue, Riverside Ca. 92504, I would like to officially submit a protest against the proposed water rates increases.

As mentioned in your letter, industrial bills will see a raise of about \$40.37 each month for the first year. Meaning that business owners will be paying an average of \$484.44 more in the first year of water rates increases. Not to mention the additional \$22.97 increase within the next 2-5 years.

Increasing water rates will make it extremely difficult for small business like myself to continue to be in business, especially since there are plenty of more increases happening in California and the city of Riverside. Just to mention a few, our sales tax has increased and minimum wage has also increased. In order for my business to be able to sustain itself, I had to pass on increases to my customers. A few have been okay with it, while others have decided to look for more producers overseas or on the other side of the border.

In order for my business to be able to afford such water rates increases proposed by the city of Riverside, I will have to once again pass on an increase to my customers. I sincerely fear that if I continue to pass on increases to my customers I will end up losing them all, and going out of business.

My company produces plastic components, and my customers come to me for being able to produce locally and at a low cost; but with so many increases going on I am not able to keep my company's promise of being cost effective.

As a concerned citizen, I ask that you reconsider such increases.





I'm a Ward 3 resident and for whatever it's worth, wanted to register my thoughts and feelings about the proposed water rate increase.

I do understand the importance of, and need for, maintenance and upgrades to the water infrastructure and capital improvements. I also understand the serious limitations on the City's budget. The piece that I'm having difficulty with has to do with the current (and, presumably future) use of water use charges.

It's my understanding that a percentage of what I pay on my water bill is siphoned off to pay for non-water-related city expenses. I know that was approved by a vote of the people, but I also know that the people weren't told, prior to that vote, that siphoning off that money would likely contribute to a water rate increase down the road because there wouldn't be enough money left to pay for necessary water-related expenses.

I'm not enough of a mathematician to be able to compute the compounding effect of the five annual rate increases in the proposal, but my subjective impression is that they add up to a very significant rate hike over the course of the five years. Simple addition (without compounding) yields a total increase of 28.25% over the five years.

Using the "Estimated Monthly Residential Bill Impacts" chart on the Notice of Public Hearing supplied by Public Utilities, the average of summer and winter charges would change from \$38.43 to \$54.49 per month over the course of the five years of increases. That's almost a 42% increase.

I suspect that, even if the funds currently being siphoned off to help the city's non-utility budget were added to the Public Utilities' budget, there still wouldn't be enough money to do all that needs doing for our water system.

I'm sure, however, that the proposed increases would not be as large as the current proposal and an approximate 42% increase, even spread over five years, is a huge increase.

I understand the issues are complex and that there are no easy answers, but it hardly seems equitable to raise water rates so dramatically when a percentage of what is being paid for water is being used for non-water-related city expenses.

We residents of Riverside seem to endure cost increases for city services on a regular basis. We receive frequent requests to kick in extra for our utilities, our schools, and police and fire protection. These cost increases are in conjunction with the taxes and levies we put up with from the state of California as well. Adding insult to injury, those of us who work in the private sector are expected to pay these increases while bringing home modest paychecks when compared to what you folks in the public sector bring home.

A little online research shows that the average annual income for families in Riverside is about \$58,000. You should compare this income to the average income for the over 100 employees of the Riverside Water Department. After backing out the water department's part-time employees, the average annual pay for all Riverside Water Department employees is just over the six-figure mark at \$100,015.35, as reported by Transparent California. As is the case with most California public employees, Riverside's water department pays its employees well above the average income of those who actually pay the bills: the city residents. It's bad enough that city manager John Russo gets to bring home such an exorbitant pay package that Mayor Bailey is filing suit to stop it. Other city departments should also take a good look at their own pay packages.

We feel that Riverside's Water Department should make a better attempt to be fair to the community that it serves. Instead of increases to monthly water bills for residents, the utility should consider more reasonable pay scales which will allow it to budget for the infrastructure improvements that it contends are the reasons for rate increases.

We pay enough for city services, while folks in the water department receive lavish compensation and benefit packages. It's time your department started cutting costs - start with compensation packages - instead of jacking up our water rates every year.


With the proposed water rates increases, I will have to work more hours to be able to still have the same income to be able to afford all living expenses for my home.



My name is Rita Turner and I reside at 6386 Riverside Avenue, Riverside, 92506. I am 91 years old and I do not own a computer so I am having my daughter, Candice, write this letter of protest on my behalf. I am protesting the proposed water rate increases for the following reasons:

1. I am 91 years old. I am on a fixed income and cannot afford these increases. I don't know of anyone who is currently working that is being given raises that equate to 30%. My Social Security certainly is not being raised 30%. How can anyone afford these increases?
2. I have seen residents removing their grass to replace it with drought-resistant landscaping. Everyone that I have spoken to would have preferred to keep their grass but felt they were being good citizens by using less water because we were all told we were in a drought and had to conserve our water.
3. I have been showering differently and even flushing my toilet differently to help conserve water. My yard is watered much less frequently and now I've learned that we have so much excess water that we're selling our water to other cities/municipalities.
4. Everywhere I drive through our city, I see yards that people are no longer watering. Is it because they can no longer afford the water? Or is it because they're using the drought as an excuse not to water or care for their yards any longer? It looks terrible.
5. Riverside itself stopped watering specimen trees and shrubs and plants and grass in areas all over the city. As an example, the once beautiful median on Central going toward Canyon Crest Towne Center was once beautiful and lush but now it is brown and the beautiful grass has died. All because we were told we had to conserve water. And to add insult to injury, we then replace the trees and shrubs that died! Those beautiful trees shouldn't have died in the first place. All of this at great cost to the residents. Who is making these decisions?
6. I live down the street from the offramp of Arlington Avenue where, instead of getting drought tolerant plants, we got bark when the freeway construction was completed. Not one tree planted. Not one plant planted. Nothing. I am so embarrassed with the way our freeway on/offramps look - there is so much litter and there are so many weeds. Why was this allowed to happen? Yet, when I drive through Corona, I see that they planted beautiful trees and shrubs on their new freeway - it looks so pretty. I am ashamed every time I drive past the on/offramps of our city. Our leaders should be ashamed. They should have fought for our city. This should not have happened. Billions and billions of dollars spent on our freeway and it looks terrible. Litter everywhere and not one single drought-tolerant plant.
7. The residents of Riverside did their part to conserve water - one of the highest percentage drops in water usage in the state. And now we're being punished. This is not right.
8. Allow us the right to use OUR water since we seem to have so much that we can sell it to other cities. Let the other cities sacrifice and go brown like we were forced to do, and even shamed into doing.
