
3575-3661 Merrill Avenue, situated on the north side of Merrill Avenue between Riverside and De Anza Avenues, and segment of Merrill Avenue between

Riverside and De Anza Avenues

PROPOSAL: The Planning Commission recommends (1) General Plan amendment to change land use designation from C-Commercial to MU-U - Mixed-Use-Urban; (2) Magnolia Avenue Specific Plan amendment to include the MU-U - Mixed-Use-Urban land use designation in the Magnolia Center District; (3) rezoning the project site from CG-SP - Commercial General-Specific Plan (Magnolia Avenue) Overlay Zones to MU-U-SP - Mixed Use-Urban and Specific Plan (Magnolia Avenue) Overlay Zones: (4) site plan review of project plans; (5) Traffic Pattern Modification Measures for the reconfiguration of Merrill Avenue; (6) vacation of three feet of Merrill Avenue; and (7) variance to allow perimeter walls higher than permitted by Code to construct a three-story, 98,608-square-foot mixed-use development, consisting of 108 residential units and 1,200 square feet of commercial space.

ENVIRONMENTAL DETERMINATION: The Planning Commission recommends (1) finding that the proposed project will not have a significant effect on the environment based on the findings set forth in the case record; and (2) adoption of a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program (MMRP) pursuant to California Environmental Quality Act Section 21081.6.
