#### REVIEW OF 2022 BY-LAW AD HOC COMMITTEE RECOMMENDATIONS – CONTINUED FROM SEPTEMBER 28, 2022

except the Chair shall not make a second or motion. The Chair shall have the right to vote on all matters. The Chair shall sign all documents on behalf of the Commission after such documents have been approved by the Commission, and shall perform such other duties and delegate responsibilities as may be imposed upon the Chair by the Commission. The Chair or the Commission Manager shall speak to the media on behalf of the Commission on official actions of the Commission. If the Chair or Manager is unavailable, defer to the City Press Information Officer. The Chair shall also perform such other duties as may be prescribed by the City Council and Mayor, so far as the requested duties are within the purview of duties of the Commission as set forth on the charter." The Chair recommended that set language should be amended to, *"If the chair or Manager is unavailable, defer to the Public Information Officer."*

The commissioners unanimously voted to approve the 2022 BY-LAW AD HOC COMMITTEE recommendations with modifications.

#### November 22, 2022:

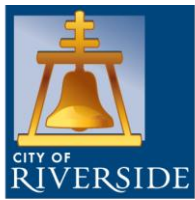
