## **ISSUE:**

## **DISCUSSION**

On January 10, 2023, the Mayor’s Nominating and Screening Committee (MNSC) established a new nomination and selection process for the City Spirit Award. The Mayor and City Council members submitted the names and biographies of community members of their choice to the City Clerk on or before February 1, 2023, for the MNSC consideration (Chart below).

In March, the MNSC shall recommend nominee(s) from the list to advance to City Council for consideration. Subsequently, the City Council will select the 2022 City Spirit Award recipient during a City Council meeting in April.
