2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 23844, AUTHORIZING THE
4 SUBMISSION OF APPLICATION AND ACCEPTANCE OF GRANT AWARD
5 FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY THROUGH THE
6 CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR THE
FISCAL YEAR 2021 EMERGENCY MANAGEMENT PERFORMANCE GRANT
PROGRAM AND AUTHORIZING THE EXECUTION OF ALL REQUIRED
DOCUMENTS BY THE CITY MANAGER, OR HIS DESIGNEE; AND
AMENDING THE BUDGET FOR FISCAL YEAR 2021-2022 ACCORDINGLY.

7 WHEREAS, the U.S. Department of Homeland Security (the "Grantor"), has been delegated
8 authority to award federal financial assistance for the Fiscal Year 2021 Emergency Management
9 Performance Grant Program; and

10 WHEREAS, on April 19, 2022, the City Council of the City of Riverside adopted Resolution
11 No. 23844, which authorized the City's submission of application and acceptance of grant award from
12 the U.S. Department of Homeland Security through the California Governor's Office of Emergency
13 Services for the Fiscal Year 2021 Emergency Management Performance Grant Program and
14 authorizing the execution of all required documents by the City Manager, or his designee, and
15 amending the budget for Fiscal Year 2021-2022, in an amount of Sixty-Three Thousand Four Hundred
16 Eighty-Eight Dollars (\$63,488); and

17 WHEREAS, grant award from the U.S. Department of Homeland Security through the
18 California Governor's Office of Emergency Services for the Fiscal Year 2021 Emergency
19 Management Performance Grant Program award entailed an additional amount of Five Thousand One
20 Hundred Ninety-Two Dollars (\$5,192), for a total of Sixty-Eight Thousand Six Hundred Eighty
21 Dollars (\$68,680); and

22 WHEREAS, because the amount awarded for the Emergency Management Performance Grant
23 exceeds the amount originally applied for and authorized by Resolution No. 23844, City Council needs
24 to amend the Resolution to account for this increased amount.

25 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
26 California, as follows:

27 Section 1: That the above recitals are found to be true and correct and are hereby incorporated
28 herein as if stated in full.

Section 2: That Resolution No. 23844 is hereby amended and the City Council of the City of Riverside hereby agrees to, and by this amended Resolution does, accept the Grant funds in the amount of Sixty-Eight Thousand Six Hundred Eighty Dollars (\$68,680), and all terms and conditions of Resolution No. 23844, not inconsistent herewith, shall remain in full force and effect and are incorporated by reference.

Section 3: The annual budget of the City of Riverside for Fiscal Year 2021 – 2022 is hereby amended by increasing the appropriations and authorized expenditures in such amount as is equal to the amount of Grant funds to be received by the City.
