CONSENT CALENDAR

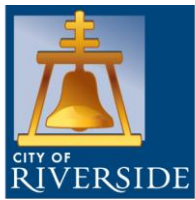

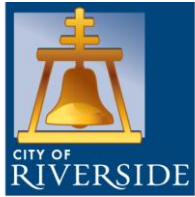
