RECITALS

WHEREAS, Owner (erroneously identified as "The City of Riverside, a California charter city and municipal corporation") and Broker entered into a California Exclusive Authorization of Lease dated January 8, 2018 ("Agreement"), for property located at California Tower, 3737 Main Street ("Property"); and

WHEREAS, the Parties now desire to amend the Agreement to extend the term of the Agreement through September 30, 2024, providing that the term shall continue on a month-to-month basis thereafter, unless cancelled by either party with thirty (30) days' prior written notice.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, Owner and Broker agree as follows:

- 1. Section 2, Term, of the Agreement is hereby amended to extend the term through September 30, 2024, providing that the term shall continue on a month-to-month basis thereafter, unless cancelled by either party with thirty (30) days' prior written notice.
- 2. All terms and conditions of the Agreement, not inconsistent with this First Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
