

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN  
4 APPLICATION FOR THE 2022/2023 WILDFIRE PREVENTION GRANT  
5 PROGRAM ADMINISTERED THROUGH THE CALIFORNIA  
6 DEPARTMENT OF FORESTRY AND FIRE PROTECTION AND  
7 AUTHORIZING THE EXECUTION OF ALL REQUIRED DOCUMENTS  
8 BY THE CITY MANAGER OR DESIGNEE.

9 WHEREAS, the Governor of the State of California in cooperation with the California State  
10 Legislature has enacted State of California Climate Investment, which provides funds to the State of  
11 California and its political subdivisions for fire prevention programs; and

12 WHEREAS, the State Department of Forestry and Fire Protection (CalFire) has been delegated  
13 the responsibility for the administration of the program within the State, setting up necessary  
14 procedures governing application by local agencies and non-profit organizations, and others under the  
15 program; and

16 WHEREAS, the applicant will enter into an agreement with the State of California to perform  
17 fire prevention on City owned property, with CalFire grant funding by removing all non-native  
18 species, including but not limited to, Tamarisk, Arundo, palm trees and Eucalyptus overgrowth within  
19 proximity to designated fire hazardous severity zones in conjunction with a Lake or Streambed  
20 Alteration Permit for the Santa Ana River Riparian Restoration, Recreation and Projection Project

21 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
22 California, as follows:

23 Section 1: Approved the filing of an application for “California Climate Investments Wildfire  
24 Prevention Grants Program” funds; and

25 Section 2: Certifies that said applicant has or will have sufficient funds to operate and maintain  
26 the project; and

27 Section 3: Certifies that funds under the jurisdiction of the City of Riverside are available to  
28 begin the project; and

Section 4: Certifies that said applicant will expend grant funds prior to March 15, 2029; and

Section 5: Appoints the City Manager, or his designee, to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests, etc., which may be necessary for the completion of the aforementioned project.
