## **BACKGROUND** CA Dept. of Housing and Community Development (HCD) Prohousing Designation Program (PDP) Prohousing Incentive Pilot Program (PIP) 2019-2020 FY Budget • December 2022 – Funded by SB 2 Awards points and/or preferential May offer Riverside a maximum of scoring in HCD programs for \$2.5 million for affordable housing jurisdictions demonstrating projects Prohousing policies/planning PDP status by March 15, 2023 Riverside CA.gov

## **BACKGROUND**

#### Western Riverside Council of Governments (WRCOG)

- Received Regional Early Action Planning (REAP) Grant funding to support member jurisdictions with various housing production programs.
- March 2022 Riverside and WRCOG enter into agreement to facilitate implementation of 6th Cycle Housing Element & PDP application.

### **APPLICATION PREPARATION**

- 1. Staff working with consultant, WSP, to develop PDP application.
- 2. At least 30/60 points needed to receive Prohousing Designation status based on four categories.
- 3. Jurisdictions must demonstrate policies corresponding to each category.
- 4. Resolutions authorizing PDP and PIP Application is required.

# PROHOUSING INCENTIVE PILOT PROGRAM

- 1. Up to \$2 million for jurisdictions with Prohousing Designation.
- 2. Up to \$500,000 additional for high-scoring PDP application.
- 3. Proposed uses:

Mulberry Gardens (State surplus land Mulberry and Holding Streets, Ward 1)	Eden Housing	150 affordable units and 59 affordable senior units	\$1,500,000
Sunrise at Bogart (Bushnell and Bogart Avenues, Ward 6)	NPHS	23 permanent supportive housing units	\$1,000,000
TOTAL			\$2,500,000

- Resolution must be adopted prior to submitting application.
- To qualify for PIP:

PDP Application due March 15, 2023



HCD must grant Prohousing status by March 30, 2023



Award and Fund Encumbrance starts May 2023 – June 2023

## **RECOMMENDATIONS**

## That the City Council:

- Adopt a resolution authorizing the City Manager, or designee, to submit an application for the HCD Prohousing Designation Program;
- 2. Adopt a resolution authorizing the City Manager, or designee, to submit an application for the Prohousing Incentive Pilot Program grant funds for an amount not to exceed \$2,500,000;

## **RECOMMENDATIONS - CONTINUED**

- 3. Authorize the City Manager, or designee, to accept and receive such funds and to execute any documents necessary to secure such award and administer the Prohousing Incentive Pilot Program grant; and
- 4. With at least five affirmative votes, authorize the Chief Financial Officer, or designee, to record an increase in revenue and supplemental appropriation in the amount of \$2,500,000 upon the award of grant funds in the Development Grants Fund, Prohousing Incentive Program.
