AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING APPROXIMATELY 8.82 ACRES OF PROPERTY LOCATED AT 2610 E. ALESSANDRO BOULEVARD FROM CR-SP — COMMERCIAL RETAIL AND SPECIFIC PLAN (SYCAMORE CANYON BUSINESS PARK) OVERLAY ZONES TO BMP-SP — BUSINESS AND MANUFACTURING PARK AND SPECIFIC PLAN (SYCAMORE CANYON BUSINESS PARK) OVERLAY ZONES.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is amended by removing from the CR-SP – Commercial Retail and Specific Plan (Sycamore Canyon Business Park) Overlay Zones and placing in the BMP-SP – Business and Manufacturing Park and Specific Plan (Sycamore Canyon Business Park) Overlay Zones, the approximately 8.82 acres of land located at 2610 E. Alessandro Boulevard, situated on the north side of Alessandro Boulevard and east of Interstate 215, identified as Assessor Parcel Nos. 263-100-014, 263-100-019, and 263-091-008, as described and depicted in Exhibit "A" attached hereto and incorporated herein by reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case Number PR-2020-000519, which conditions, restrictions and covenants are incorporated herein by reference.

Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This Ordinance shall become effective on the 30th day after the date of its adoption.
