IHO was awarded \$7.6 million in Multifamily Housing Program (MHP) funds and California Tax Credit Allocation Committee funding. The developer has selected a general contractor.</p> <p>HOME Loan Agreement was presented to the City Council for consideration on December 6th. Escrow closed on December 20, 2022. Preconstruction work in underway. Construction Set to begin early 2023</p>

The xeriscaping project is underway with six approved applications with 13 total applications with installations to begin in January. There are eight pending applications for solar installation and eight approved with two ready for installation starting in January once permits are approved.

An Amendment to increase HOME funds from \$354,726 to \$510,788 approved by City Council November 15, 2022. Construction has completed. Certificate of Occupancy expected in early January. They are currently undergoing tenant review and expect to have the two units occupied by March 2023.
