COUNCILMEMBER CONDER'S PUBLIC COMMENT

Following discussion, it was moved by Member Newman and seconded by Member Foley to read Councilmember Conder public comments into the record. The motion carried with Chair DeHerrera, Members Foley, and Newman voting aye, and Members Vega and DeMont voting no.

CODE OF ETHICS COMPLAINT PRE-HEARING CONFERENCE

Chair De Herrera opened the pre-hearing conference proceedings on the Code of Ethics and Conduct complaint filed by Jenn Larratt-Smith against Councilmember Conder alleging a violation of Riverside Municipal Code Section 2.78.060(M) Violation of federal, State, or local law prohibited in September 2021 and on November 9, 2021, February 24, 2022, May 18, 2022, August 18, 2022, and September 7, 2022.

Following review of the Code of Ethics and Conduct complaint filed by Jenn Larratt-Smith against Councilmember Conder alleging a violation of Riverside Municipal Code Section 2.78.060(M) Violation of federal, State, or local law prohibited, it was moved by Hearing Panel Member Foley and seconded by Hearing Panel Member Vega to determine that the complainant has failed to show that it is more likely than not that there may be a potential violation of the prohibited conduct in regard to Riverside Municipal Code 2.78.060(M) Violations of federal, State, or local law prohibited. The motion carried.

Chair De Herrera instructed the City Clerk to prepare a Statement of Findings of the Hearing Panel stating there was no evidence presented in the record of any violation of Riverside Municipal Code Section 2.78.060 (M) Violation of federal, State, or local law prohibited as a violation of State of Federal law requires a conviction. The complaint was dismissed.

The hearing panel adjourned at 7:40 p.m.
