

## **BACKGROUND**

	DACKOKOUND
Item	Action
1	In May 2017 City Council approved a 5-year spending plan for Measure Z, including \$2.875 million in annual funding for roads rehabilitation.
2	In September 2017, IMS completed a pavement condition assessment of 875.4 centerline City miles which determined an overall Pavement Condition Index Score of 61 for the City roads.
3	In September 2018, the City Council received a report on the Pavement Management Program Update and Analysis.
4	In February 2019, the Budget Engagement Commission received a report and recommended increased roadway maintenance funding.
5	In April 2019, the City Council approved \$1.5 million/annually in Measure Z funding through fiscal year 2022-23.
6	In May 2019, the City Council approved an additional supplemental appropriation of \$3.5 million in Measure Z funds for the Pavement Management Program in Fiscal Year 2019-20, and directed Public Works and Finance Departments to return each Spring with an annual progress report and an assessment of finances to consider fiscal year appropriations of \$3.5 million for the continued support of the Pavement Management Program.


#### **ROADWAY NETWORK**

- Pavement Condition Index (PCI) score for the City's network is 61 (Newly paved street has a PCI of 100);
- 2. 12.7% of roads have a rating of "Poor" or "Very Poor" and correlate to a PCI score of 0-40.

#### SUPPLEMENTAL APPROPRIATION

The additional \$3.5 million appropriation will make a positive difference and may fund:

- 1. Pave 3 miles of Arterial Roads; or
- 2. Pave 7 miles of Minor/Collector Roads; or
- 3. Slurry Seal 88 miles of Local Residential Streets.

875 miles of road in the City, should average 44+ miles of improvements each year.
