Public Hearing was called to amend Chapter 5.77 Cannabis Business Activities of Title 5 and Title 19 Zoning of the Riverside Municipal Code (RMC) related to Commercial Cannabis Business (CCB) Program. One person spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Mill to (1) determine that Planning Case PR-2025-001795 (Zoning Code Text and Cannabis Business Activities Amendment) is exempt from further California Environmental Quality Act (CEQA) review pursuant to Section 15601(b)(3) of the CEQA Guidelines as it can be seen with certainty approval of the project will not have an effect on the environment; (2) approve Planning Case PR-2025-001795 pursuant to the findings made in the report; (3) introduce an Ordinance amending Chapter 5.77 (Cannabis

The motion failed for lack of majority vote with Councilmembers Cervantes and Mill voting aye and Councilmembers Falcone, Conder, and Perry voting nay, Councilmember Hemenway recusing, and Councilmember Robillard absent.

Following further discussion, a motion was made by Councilmember Cervantes and seconded by Councilmember Falcone to (1) determine that Planning Case PR-2025-001795 (Zoning Code Text and Cannabis Business Activities Amendment) is exempt from further California Environmental Quality Act (CEQA) review pursuant to Section 15601(b)(3) of the CEQA Guidelines as it can be seen with certainty approval of the project will not have an effect on the environment; (2) approve Planning Case PR-2025-001795 pursuant to the findings made in the report; and (3) introduce an Ordinance amending Chapter 5.77 (Cannabis Business Activities) and Title 19 (Zoning) of the Riverside Municipal Code. The motion failed for lack of four affirmative votes with Councilmembers Falcone, Cervantes, and Mill voting aye and Councilmembers Conder and Perry voting nay, Councilmember Hemenway recusing and Councilmember Robillard absent.

Councilmember Perry announced that the closed session items regarding (1) Tony Platt v. City of Riverside; and (2) City of Riverside v. Councilmember Charles Conder and former Councilmember Steven R. Adams were continued.

The Mayor and City Council recessed at 3:21 p.m. and reconvened at 6:15 p.m. with Mayor Lock Dawson presiding and all Councilmembers present except Councilmember Robillard.

LEASE AGREEMENT AMENDMENT - TENANT IMPROVEMENT CREDIT

The City Council (1) approved a Third Amendment to the Riverside Municipal Airport Lease Agreement with Riverside Airport Café, establishing a tenant improvement credit, 5-year payment plan, revised rent rate and revised revenue share rate; and (2) authorized the City Manager or his designee to execute the Third Amendment to Riverside Airport Lease Agreement with the Riverside Airport Café, including making minor and non-substantive changes.

BOARD AND COMMISSIONS APPOINTMENTS

The Mayor and City Council appointed (1) Jordan Wright to the Board of Public Utilities Ward 1 seat for a term through March 1, 2028; and (2) Mary Carter to the Museum of Riverside Board Ward 7 seat for a term through March 1, 2029.

CITY MANAGER SETTLEMENT AUTHORITY - RESOLUTION

The City Council approved the Governmental Processes Committee recommendation amending City Manager's settlement authority to adopt a Resolution increasing the City Manager's Settlement Authority for various claims from \$25,000 to \$50,000; amending Resolution No. 23792; which amendment is to be effective upon adoption; whereupon the title having been read and further reading waived, Resolution No. 24271 of the City Council of the City of Riverside, California, Increasing the City Manager's Settlement Authority for Various Claims from \$25,000 to \$50,000, Amending Resolution No. 23792, was presented and adopted.

PURCHASE AND SALE AGREEMENT - THIRD STREET GRADE SEPARATION PROJECT The City Council (1) approved the Purchase and Sale Agreement with Helix Street, LLC., for \$1,600,000 and estimated fees of \$50,000; and (2) authorized the City Manager, or his designee, to execute the agreement, including making minor and non-substantive changes, and to sign all documents and instruments necessary to complete the transaction.

AGREEMENT - CITYWIDE PRINTING SERVICES

The City Council (1) approved the Services Agreement with Mainstreet Communication, Inc., dba PrintMyStuff.com for Citywide printing services in the amount of \$750,000 for the initial one-year term with the options to extend for four one-year terms; (2) authorized the City Manager or Designee, to execute all term extensions with an annual contract amount of \$750,000 for a total contract of \$3,750,000; (3) authorized 20 percent change order authority of \$750,000 over the full contract term for a total contract amount not-to-exceed \$4,500,000; and (4) authorized the City Manager, or his designee, to execute the Services Agreement with Mainstreet Communications, Inc., and any other documents to effectuate the agreement, including making minor non-substantive changes.

UNITED STATES DEPARTMENT OF HOMELAND SECURITY - FISCAL YEAR 2023 STATE HOMELAND SECURITY PROGRAM GRANT - SUPPLEMENTAL APPRROPRIATION - RESOLUTION The City Council (1) adopted a Resolution authorizing the acceptance of a grant award from the U.S. Department of Homeland Security for the 2024 State Homeland Security Program grant funds, administered through the Riverside County Emergency Management Department in the amount of \$67,000; (2) authorized the Chief Financial Officer, or designee, to record an increase in revenue and record a supplemental appropriation in the amount of \$67,000, or the actual award amount, in the Grants and Restricted Programs Fund 2024 County-Wide Hazmat Operations Group revenue and expenditures accounts; and (3) authorized the City Manager, or his designee, to execute the County-Wide Hazmat Operations Group from the State Homeland Security Program, including making minor and non-substantive changes; whereupon, the title having been read and further reading waived, Resolution No. 24272 of the City Council of the City of Riverside, California, Authorizing the Submission of Application and Acceptance of Grant Award from the U.S. Department of Homeland Security Through the California Office of Emergency Services for the Fiscal Year 2024 State Homeland Security Program Grant (SHSP) Which Includes the Countrywide Hazmat Operation Group (CHOG) Program, and Authorizing the Execution of all Required Documents by the City Manager, or His Designee; and Amending the Budget for Fiscal Year 2024-2025 Accordingly, was presented and adopted.

AFFORDABLE HOUSING AND SUSTAINABLE COMMUNITIES AGREEMENT - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved an Affordable Housing and Sustainable Communities Subrecipient Agreement with the Public Works Department of the City of Riverside for a \$3,189,779 grant to support Sustainable Transportation Infrastructure (STI) improvements related to the Mission Heritage Plaza affordable housing development; and (2) authorized the City Manager, or designee, to execute all program related documents and instruments, including making minor non-substantive changes as necessary to implement the Affordable Housing and Sustainable Communities Subrecipient Agreement.

SECURITY CAMERA EQUIPMENT PURCHASE - SURVEILLANCE CAMERAS

The City Council (1) approved the purchase of security camera equipment and installation services from Convergint Technologies, Anaheim, under Sourcewell Cooperative Purchasing Agreement 121024-CTL, in the amount of \$178,538 plus a contingency in the amount of \$85,000 for a total of \$263,538; and (2) authorized the City Manager, or designee, to execute the Agreement, including making minor non-substantive changes.

NATIONAL RECREATION AND PARK ASSOCIATION (NRPA) SUPPORTING HEALTHY AGING -GRANT AWARD - SENIOR PROGRAMMING - VILLEGAS COMMUNITY CENTER -SUPPLEMENTAL APPROPRIATION

The City Council (1) accepted grant funds from the National Recreation and Park Association SHAPR Grant in the amount of \$3,000 to expand senior programming at Villegas Community Center; (2) authorized the Chief Financial Officer, or designee, to record an increase in revenues in the amount of \$3,000 and appropriate expenditures in the same amount to the Grants and Restricted Programs Fund, NRPA SHAPR 24/25 grant revenue and expenditure accounts; and (3) authorized the City Manager, or designee, to execute the National Recreation and Park Association SHAPR Grant agreement including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transaction, including, but not limited to agreements, and payment requests necessary to complete grant funded activities.

AGREEMENT AMENDMENT - ANNUAL SWIMMING POOL MAINTENANCE SERVICES

The City Council (1) approved the Second Amendment to Services Agreement for Annual Swimming Pool Maintenance Services with Service First for a six-month extension from July 1, 2025 to December 31, 2025 in the amount of \$131,836.44; (2) authorized

15 percent change order authority not-to-exceed the amount of \$19,773.97 for a total increase of \$151,610.41; and (3) authorized the City Manager, or designee, to execute the Second Amendment, including making minor and non-substantive changes.

AGREEMENT - SPECIALTY VEHICLE EQUIPMENT, REMOVAL, AND INSTALLATION SERVICES The City Council (1) approved the Services Agreement with Innovative Design and Sheet Metal Products, Inc., dba Innovative Emergency Equipment, Riverside, for specialty vehicle equipment, removal, and installation services for Police Department vehicles with a term ending September 30, 2029 in the amount not-to-exceed \$463,958.48 for Fiscal Year 2024/25 and \$500,000 per year for Fiscal Year 2025/26 through Fiscal Year 2028/29 for a total agreement amount of \$2,463,958.48; and (2) authorized the City Manager, or designee, to execute the Services Agreement, including making minor, non-substantive changes.

SECURITY CAMERA EQUIPMENT PURCHASE - CITYWIDE NETWORK

The City Council received a report on the purchase of security camera equipment from VectorUSA for the Citywide network. No one spoke on the matter.

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Mill to (1) authorize the purchase of security camera equipment for Citywide network from VectorUSA, Rancho Cucamonga, California, under Omnia Cooperative Purchasing Agreement R200803, in the amount of \$144,510.09; and (2) authorize the City Manager, or designee, to execute all documents necessary to effectuate this purchase, including making minor and non-substantive changes. The motion carried unanimously.

PUBLIC HEARING

AMENDMENT - PROPOSED FISCIAL YEAR 2025-2026 BIENNIAL BUDGET - RESOLUTION Public Hearing was called to consider the proposed amendment of Fiscal Year 2025-2026 of previously adopted Fiscal Year 2024-2026 Biennial Budget and adopt a resolution amending Resolution No. 24131 to amend the two-year. Two people spoke on the matter. The public hearing was officially closed.

The motion carried with Councilmembers Falcone, Cervantes, Conder, Mill, Perry, and Hemenway voting aye and Councilmember Robillard absent.

Whereupon, the title having been read and further reading waived, Resolution No. 24273 of the City Council of the City of Riverside, California, Amending Resolution No. 24131 to Amend the Two-Year Budget of the City of Riverside for the Fiscal Year Beginning July 1, 2025, and Ending June 30, 2026, was presented and adopted.
