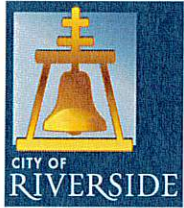
COMMUNICATIONS

LEGISLATIVE UPDATE

Public Works Deputy Director Nathan Mustafa provided updates on (1) Assembly Bill 98 regarding truck routes and possible compliance as part of the City's General Plan update; (2) Senate Bill 1123 and Senate Bill 684 which may reduce the City's discretion related to subdivisions of ten or fewer parcels, Assembly Bill 130 and Senate Bill 131 allowing some housing developments to be exempt from California Environmental Quality Act (CEQA) analysis, and (3) Senate Bill 601 regarding Water Boards' regulation of waste and storm water discharge.

PROJECT UPDATES

Public Works Deputy Director Nathan Mustafa provided project updates regarding the (1) approval of the Pavement Management Program and use of the paving map; (2) Trench Cut fee; (3) Traffic Index to determine replacement of road thickness as part of the General Plan; and (4) receipt of Caltrans E-76 Authorization for next Highway Safety Improvement project, which includes the Citywide signal head replacement and a new
