For example, the Commission on Disabilities will receive an annual update from Riverside Connect, the transportation service the City provides to seniors and disabled individuals.

3. Engage with the community members to identify barriers that are faced and formulate possible resolutions.



Community Well-Being

Goal 2.5 - Foster relationships between community members, partner organizations, and public safety professionals to define, prioritize, and address community safety and social service needs The Commissioners will attend community events such as the annual health fair that is held at the Janet Goeske Senior Center in October.

The Commissioners will work on meeting with and collaborating with City Council members in order to address disability needs within the community.
