TO THE 2017-2018 HUD ANNUAL ACTION PLAN**

**NOTICE IS HEREBY GIVEN** that the City of Riverside has prepared its draft amendment of the Housing and Urban Development (HUD) Annual Action Plan for program years 2017-2018. The publication of this notice is the beginning of the public review period required under Federal Regulation 21 CFR 91.105 (b)(2). The public review and written comment period will begin March 7, 2021, and run through April 6, 2021.

At this meeting, the City Council will receive public comment on the draft 2017-2018 HUD Annual Action Plan that is to be submitted to the U.S. Department of Housing and Urban Development (HUD).

**BACKGROUND**

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside's Five-Year Consolidated Plan in 2015. The Consolidated Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources [such as Community Development Block Grant funds (CDBG), HOME, Housing Opportunities for People with AIDS (HOPWA), and Emergency Shelter Grants (ESG)] needed to continue implementing existing programs and activities and to formulate programs and activities needed to address the unmet needs. Since the approval of the Consolidated Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2017-2018 implements the strategy and goals identified in the Consolidated Plan.

Federal Regulation 24 CFR 91.105 requires the City to notify and provide its citizens an opportunity to comment and provide input on proposed changes to an approved plan. This notice meets the requirement and is in compliance with the law. Under the Citizen Participation Plan any CDBG projects which have more than 10% of their original allocation remaining unused at completion must be presented to the public before the remaining funds can be unallocated for future use. The proposed amendment to the

2017-2018 HUD Annual Action Plan will modify the allocations of two capital improvement projects with more than 10% of their original allocations remaining so the projects can be closed, and the remaining unused project balances totaling \$213,044 can be released to the Unprogrammed Funds account for future capital improvement or economic development projects. The proposed Substantial Amendment to the approved Plan affected by this Notice will allow the City to reduce the allocations of the following previously approved Capital Improvement Projects: Bordwell Park Nati Fuentes Centro de Ninos Flooring from \$248,299 to \$88,200 and Hulen Place Tenant Improvements from \$115,000 to \$62,055.
