NOTICE IS HEREBY FURTHER GIVEN that the City of Riverside has prepared its draft update of the HUD Annual Action Plan for program year 2019-2020. The U.S. Department of Housing and Urban Development (HUD) has granted a waiver to the Citizen Participation Process in order to expedite the use of funds under the Coronavirus Aid, Relief and Economic Security Act (CARES Act).

At this meeting, the City Council will receive public comment on the draft HUD Annual Action Plan 2019-2020 that is to be submitted to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside's Five-Year Consolidated Plan in 2015. The Consolidated Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources [such as Community Development Block Grant funds (CDBG), HOME, Housing Opportunities for People with AIDS (HOPWA), and Emergency Shelter Grants (ESG)] needed to continue implementing existing programs and activities and to formulate programs and activities needed to address the unmet needs. Since the approval of the Consolidated Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2019-2020 implements the strategy and goals identified in the Consolidated Plan.

The City of Riverside has been allocated a second round of funding authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act – CV 2), Public Law 116-136. This allocation includes Community and Economic Development Grant Funds (CDBG-CV) in the amount of \$2,047,949 and Emergency Solutions Grant Funds (ESG-CV 2) in the amount of \$3,126,622

These special CDBG-CV 2 funds are to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID-19).

The City is amending its FY 2019-2020 HUD Annual Action Plan to allocate the CDBG-CV 2 funding as follows:

1. Riverside Food Resiliency Programs: \$1,638,359.20
2. Administration: \$409,589.80

These special ESG-CV2 funds are to be used to prevent, prepare for, and respond to the coronavirus pandemic (COVID-19) among individuals and families who are homeless or receiving homeless assistance; and to support additional homeless assistance and homelessness prevention activities to mitigate the impacts of COVID-19.

The City is amending its FY 2019-2020 HUD Annual Action Plan to allocate the ESG-CV 2 funding as follows:


1. Riverside Shelter Cabin Village (non-congregate shelter) operations: \$1,269,611
2. Bridge Housing (non-congregate shelter) operations: \$1,242,118
3. Homeless Street Outreach: \$166,678
4. Riverside Emergency Shelter Operations: \$365,000
5. Administration: \$83,215
