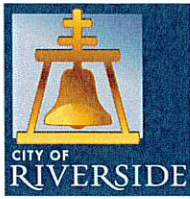
Mayor Lock Dawson called the meeting to order at 3:00 p.m.

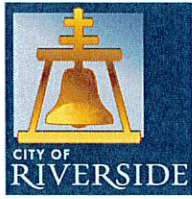
### PUBLIC HEARING

#### RIVERSIDE MUNICIPAL CODE AMENDMENTS - 2025 EDITION OF CALIFORNIA BUILDING AND FIRE CODES - ORDINANCES ADOPTED - RESOLUTION

Public hearing was called to consider the adoption of a Resolution to support local amendments to the 2025 Edition of California Code of Regulations Title 24, the California Building Standards Code, and ordinances to adopt the State's update to the California Code. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Perry to (1) adopt the Ordinances introduced on October 21, 2025, and listed as follows (a) adopting the 2025 Edition of California Code of Regulations Title 24, the California Building Standards Code with local amendments thereto (b) amending Chapter 1.17 of the Riverside Municipal Code, Administrative Code Enforcement Remedies, and (c) amending Chapter 5.59 of the Riverside Municipal Code, Fire Alarm System; and (2) adopt a Resolution making the necessary express findings as required by state law to support local amendments to the 2025 edition of California Code of Regulations Title 24, the California Building Standards Code. 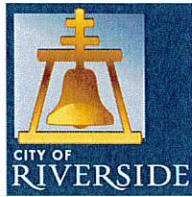

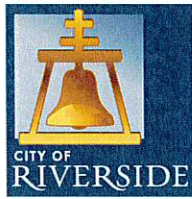

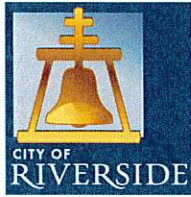

The City Council (1) adopted the Resolution supporting the amendment to the 2014 March Air Reserve Base/Inland Port Airport Land Use Compatibility Plan, authorizing the City's participation in the amendment process; and (2) approved the City's financial contribution in the amount of \$25,000 to the Riverside County Airport Land Use Commission for the City's proportional share of costs associated with the amendment; and (3) authorized the City Manager, or his designee, to execute any related documents, agreements, or correspondence necessary to carry out the City's participation in the amendment process, including making minor, non-substantive changes as required.

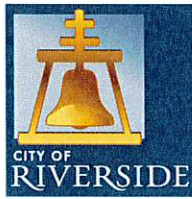
### RIVERSIDE HISTORY WALK GUIDELINES - COMMERATIVE STONES

- The request must represent a historical event in Riverside history post - 1976.



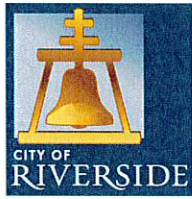

- The request shall be approved/denied by the City's Historic Preservation Officer upon advisement from the Soroptimist International of Riverside and local history organizations including but not limited to the Cultural Heritage Board, Old Riverside Foundation, and Riverside Historical Society.
- Events shall exemplify or reflect special elements of the City's History including:
  - A. Cultural - The event represents significant artistic, educational, religious, or community traditions that express Riverside's cultural identity or diversity.
  - B. Social - The event illustrates important aspects of community life, social change, or collective experience that have shaped the character or values of Riverside's residents.
  - C. Economic - The event is associated with major developments in commerce, industry, agriculture, or innovation that contributed to Riverside's economic growth or transformation.
  - D. Political - The event is linked to civic leadership, governance, or public movements that influenced local policy, social justice, or the City's political evolution.
- The requesting organization shall fund the fabrication of the stone and artistic work needed to establish a stone design that compliments existing stones.
- The stone's artwork design shall be approved by the City's Arts & Cultural Affairs Deputy Director and Historic Preservation Officer.
- The City of Riverside shall fund the installation of the approved addition on the sidewalk along Main Street via City Council approved funding sources such as a forthcoming road construction contract.
- The requesting organization shall provide a \$500 donation to the History Walk endowment fund for future care and maintenance.
- Addition of stones shall be installed in the sidewalk along Main Street to follow the existing pattern of the History Walk leading south towards 14th Street. Once full to

The City Council approved the City Council Safety, Wellness and Youth Committee's recommendation to support the naming of the new gymnasium at Bordwell Park in honor of long-time leader Dell Roberts, to be formally known as the Dell Roberts Gymnasium.

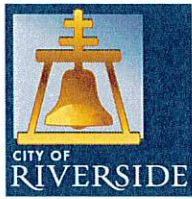
### REQUEST FOR PROPOSAL 2458 AGREEMENTS - PRE-EMPLOYMENT PHYSICALS - DEPARTMENT OF TRANSPORTATION (DOT) AND DEPARTMENT OF MOTOR VEHICLES (DMV) MEDICAL EXAMS

The City Council (1) approved a Professional Services Agreement with both Coastal Occupational Medical Group, dba Akeso Occupational Health, a California corporation, and Occu-Med Ltd, a Delaware corporation, to provide pre-employment physicals and (DOT) and (DMV) medical exams for the City of Riverside in an amount not-to-exceed \$100,000 annually per company, with the initial term of the agreement from full execution through June 30, 2028, with the option to extend for two years; and (2) authorized the City Manager, or their designee, to execute the extensions of the professional services agreements if desired and make minor and/or non substantive changes.

### LA SIERRA PARK AMERICAN WITH DISABILITIES ACT IMPROVEMENT PROJECT - SUPPLEMENTAL APPROPRIATION - INTERFUND TRANSFER

The City Council authorized the Chief Financial Officer, or designee, to record a supplemental appropriation and interfund transfer in the amount of \$17,000, from the Grants and Restricted Fund to the Capital Outlay Fund, La Sierra Park American with Disabilities Act Per Capita Project revenue and expenditure accounts, funded by a bond settlement payment.

### AGREEMENT - OPERATION AND MAINTENANCE OF PEDAL BOAT RENTAL CONCESSION - FAIRMOUNT PARK - 2601 FAIRMOUNT

The City Council (1) approved the Concessionaire Agreement with Freetime, Inc., doing business as Wheel Fun Rentals, for the operation and maintenance of the pedal boat rental concession at Fairmount Park effective November 2025 for a two-year term, with minimum annual revenue of \$15,000; and (2) authorized the City Manager, or designee, to execute the Agreement and optional term extension with Freetime, Inc., doing business as Wheel Fun Rentals, including making minor and non-substantive changes.

### GRANT AWARD - STATE OF CALIFORNIA CITIZENS' OPTION FOR PUBLIC SAFETY PROGRAM 2026 - SUPPLEMENTAL APPROPRIATION

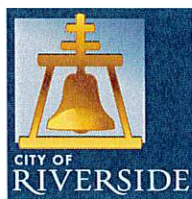
The City Council (1) accepted a grant award from the State of California Citizens' Option for Public Safety program 2026 in the amount of \$489,549 or the actual grant amount, plus a growth payment into the Special Deposits Fund, Police State COPS Funding Program; (2) upon receipt of the grant award, authorize the Chief Financial Officer, or designee, to record an increase in revenues and appropriate expenditures in the amount of the grant award in the Grants and Restricted Programs Fund, Police State COPS Funding Program revenue and expenditure accounts; and (3) authorized the City Manager, or designee, to execute necessary documents on behalf of the City making non-substantive changes as necessary.

### AGREEMENT - CONTROL SYSTEM UPGRADES - CLEARWATER POWER PLANT

The City Council (1) approved the Professional Consultant Services Agreement with ABB, Inc., Cary, North Carolina, to perform control system upgrades at the Clearwater Power Plant for \$1,640,971.17; and (2) authorized the City Manager, or designee, to execute the Professional Consultant Services Agreement with ABB, Inc., including the ability to make non-substantive changes.

### TRANSPORTATION ELECTRIFICATION AND ELECTRIFY RIVERSIDE REBATE PROGRAM UPDATE - SUPPLEMENTAL APPROPRIATIONS

The City Council (1) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the total amount of \$500,000 from the Electric Fund, Low Carbon Fuel Reserve Account and appropriate expenditures to the Public Access Electric Vehicle Electrical Infrastructure Rebate Account; (2) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the total amount of \$1,000,000 from the Electric Fund, Low Carbon Fuel Reserve Account and appropriate expenditures to the Electric Public Transit Program Account; (3) approved an increase to

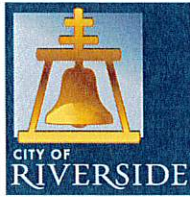

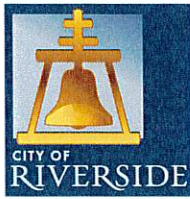

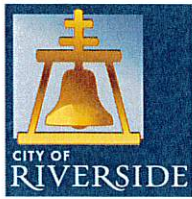
