

FOURTH AMENDMENT

TO AGREEMENT FOR THE YOUTH SPORTS OFFICIALS AND SCOREKEEPERS

DANNY FULLER DBA SPORTS INNOVATORS

This FOURTH AMENDMENT TO AGREEMENT FOR THE YOUTH SPORTS OFFICIALS AND SCOREKEEPERS ("Third Amendment") is made and entered into this _____ day of _____, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and DANNY FULLER, a sole proprietor doing business as SPORTS INNOVATORS ("Contractor").

RECITALS

WHEREAS, on or about July 26, 2016, City and Contractor entered into an Agreement for Contractor to furnish qualified sports officials and scorekeepers necessary for Youth Sports Programs and those other related services as set forth in Exhibit "A" of the Agreement ("Agreement");

WHEREAS, Section 3 of the Agreement states that the Agreement term shall be for a period of two (2) years commencing July 1, 2016, through June 30, 2018, and that the Agreement may be extended for three (3) additional periods of one (1) year each, not to exceed five (5) years;

WHEREAS, on or about August 29, 2018, City and Contractor entered into a First Amendment to the Agreement for an additional one-year term to expire on June 30, 2019, and for additional compensation not to exceed Twenty Thousand Dollars (\$20,000.00) per year;

WHEREAS, on or about June 25, 2019, City and Contractor entered into a Second Amendment to the Agreement for an additional one-year term to expire on June 30, 2020, and for additional compensation not to exceed Twenty Thousand Dollars (\$20,000.00) per year;

WHEREAS, on or about July 1, 2020, City and Contractor entered into a Third Amendment to the Agreement for an additional one-year term to expire on June 30, 2022, and for additional compensation not to exceed Twenty-Two Thousand Dollars (\$22,000) per year;

WHEREAS, City has been satisfied with the performance of Contractor;

WHEREAS, City and Contractor desire to extend the Agreement term for a six-month period beginning July 1, 2022 and terminating December 31, 2022 ("Extended Term"); and

WHEREAS, City and Contractor have agreed the amount of compensation for the Extended Term shall be for the amount not to exceed Twenty-Four Thousand Twenty-Four Dollars (\$24,024) per year.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. The Agreement term is hereby extended for a six-month period beginning July 1, 2022 and ending December 31, 2022.
2. Compensation of the Agreement is hereby amended to an amount not to exceed Twenty-Four Thousand Twenty-Four Dollars (\$24,024) per year.
3. All terms and conditions of the Agreement, not inconsistent with this Fourth Amendment, shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.

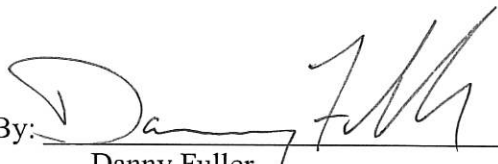
