DISCUSSION CALENDAR

REVIEW OF UNDOCUMENTED RESIDENTIAL LEGACY STRUCTURES

Following discussion, it was moved by Vice Chair Falcone, and seconded by Member Cervantes to (1) receive, and order filed the report on undocumented residential legacy structures; (2) recommend the City Council consider Option 3 - Combination approach which enables multiple tools that address the unpermitted structures or alterations with more options for compliance for customers, those issued permits will gain benefits to the Safety First Amnesty Program, and submit plans, obtain permit and undergo inspections in accordance with codes in effect at the time of construction, those who wish to obtain approval to use and occupy structures or alterations through the Certificate of Unpermitted/Non-Complying Conditions and undergo a life safety inspection until such time alterations may be proposed which would require code compliance; and (3) change the language of "Undocumented residential legacy structures" to "Unpermitted residential legacy structures". The motion carried unanimously.

<u>PROPOSED ZONING CODE AMENDMENTS RELATED TO INDUSTRIAL WAREHOUSES AND DISTRIBUTION FACILITIES</u>

Following discussion, it was moved by Member Cervantes and seconded by Vice Chair Falcone to (1) receive, and order filed the report on the proposed amendments to the City's industrial development regulations including warehousing and distribution facilities; and (2) direct staff to proceed with Option 1 to implement the proposed Zoning Code
