

SECOND AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT

RETAIL MARKETING SERVICES, INC. dba CARTRAC

[Cart Retrieval Services]

THIS SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Second Amendment") is made and entered into this _____ day of _____, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and RETAIL MARKETING SERVICES, INC., a California corporation doing business as CARTRAC ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated April 26, 2019 ("Agreement") for Cart Retrieval Services ("Project"); and

WHEREAS, the City and Consultant entered into a First Amendment to the Agreement increasing the Compensation by Sixty Thousand Dollars (\$60,000) on February 3, 2022, and

WHEREAS, the Agreement is set to expire on June 30, 2022; and

WHEREAS, the City desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the term of the Agreement for one additional year, to end June 30, 2023; and

WHEREAS, the City and Consultant also desire to increase Compensation by an additional One Hundred Twenty Thousand Dollars (\$120,000) for the new term ending June 30, 2023.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 2. Term is hereby amended and shall be effective until June 30, 2023.
2. Section 3. Compensation/Payment is hereby amended to add an additional One Hundred Twenty Thousand Dollars (\$120,000), for a contract total of Four Hundred Eighty Thousand Dollars (\$480,000).

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
