28 The department head may determine in writing that a particular consultant, although a “designated position,” is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements described in this

1 section. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement
2 of the extent of disclosure requirements. The department head's determination is a public record and shall be retained for public
3 inspection in the same manner and location as this conflict of interest code.

7 **Broad Disclosure**

8 1. Must report investments, business positions, and income from sources located in, planning to
9 do business in, or doing business in the City of Riverside; and

10 Interests in real property located in the City of Riverside and also within a two-mile radius of any
11 property owned or used by the City of Riverside which is not within the City limits.

12 **Real Property Disclosure**

13 2. Must report interests in real property located in the City of Riverside and also within a two-
14 mile radius of any property owned or used by the City of Riverside which is not within the City
15 limits.

16 **Financial Interest Disclosure**

17 3. Must report investments, business positions, and income from sources located in, planning to
18 do business in, or doing business in the City of Riverside.

19 **Disclosure Based on Department**

20 4. Must report investments, business positions, and income from business entities located in,
21 planning to do business in, or doing business with the City of Riverside subject to the following: no
22 financial interest need be reported unless it is in or from a source which provides services, supplies,
23 material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
24 or licensing authority of the department which filer is employed.

25 **Disclosure Based on Position**

26 5. Must report investments, business positions, and income from business entities located in,
27 planning to do business in, or doing business with the City of Riverside subject to the following: no
financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
or licensing authority of the position which the filer currently fills.

28 **Consultant Disclosure**

6. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no
financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
or licensing authority of the department by which the consultant is employed.

Disclosure Based on Board and Commission Membership

7. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no
financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
or licensing authority of the department with which filer's board or commission is associated.

No Disclosure

8. Need not file Statement of Economic Interest as members are not deemed to be designated positions.

State Filers

9. Need not file an additional Statement of Economic Interests under this code as their filing with the Fair Political Practices Commission fulfills reporting requirements. They are included in this code only for disqualification purposes.

*Nothing contained in this conflict of interest code shall be interpreted to require the reporting of gifts from outside the City of Riverside's jurisdiction if the purpose of disclosure of the source of the gift does not have some connection with or bearing upon the functions or duties of the position for which the reporting is required. Nothing in this language is intended to create an inference that all gifts within the jurisdiction are reportable. (2 California Code of Regulations section 18730.1).
