

RECOMMENDATIONS

That the City Council:

- Accept a grant award from the California Department of Forestry and Fire Protection in the amount of \$1,275,200 to complete foliage and brush remediation project for the Boy Scout Camp area of Fairmount Park;
- 2. With at least five affirmative votes, and upon execution of grant agreement, authorize the Chief Financial Officer or designee to record an increase in revenues for the Santa Ana River Fire Prevention Project Account in the amount of \$1,275,200 and a supplemental appropriation in expenditures in the same amount to the Santa Ana River Fire Prevention Project Account;

RECOMMENDATIONS CONT.

- Authorize a grant funding Agreement with the California Department of Forestry and Fire Protection to compete the project;
- 4. Authorize a grant funded purchase order for a John Deere 333G Track Loader with a John Deere Grapple Bucket, Fecon Bullhog Mulching Attachment and Stump grinder in the amount of \$223,886.87; and
- 5. Authorize the City Manager or their designee to execute all necessary documents, including but not limited to applications, payment requests, agreements, and amendments necessary to secure grant funds and implement the approved grant project, including making minor and nonsubstantive changes.
