SUBJECT: SCHOOL CROSSING GUARD SERVICES AND COST SHARING OPTIONS WITH RIVERSIDE AND ALVORD UNIFIED SCHOOL DISTRICTS

ISSUE:

Receive an update on the school crossing guard service program and provide input on the cost sharing options with Riverside and Alvord Unified School Districts.

RECOMMENDATION:

That the Safety, Wellness, and Youth Committee receive an update on the school crossing guard service program and provide input on the cost sharing options with Riverside Unified School District (RUSD) and Alvord Unified School District (AUSD).

BACKGROUND:

Prior to 2014, the Public Works Department was responsible for staffing and managing the City's crossing guard program. On April 15, 2014, the City Council approved a five-year contract with All City Management Services, Inc. (ACMS), which expired on June 30, 2019. The City funded crossing guard services at 100% through June 30, 2019.

On May 14, 2019, staff introduced a new contract proposal for crossing guard services for a fiveyear term with an option to extend an additional two-year term in an amount not to exceed \$4,966,041.60. In response to budgetary constraints, the City Council rejected the proposed contract and directed staff to explore cost-sharing models with both AUSD and RUSD.

On July 16, 2019, staff presented the City Council with a cost sharing plan phased in over a fiveyear period. At that time the City Council directed staff to work with the school districts to move to a 50/50 cost sharing model within two but no more than three years maximum.

On August 22, 2019, RUSD's Board of Education Finance Subcommittee recommended support of the proposed costs sharing model which was approved by RUSD's board on September 3, 2019. AUSD staff also recommended support of the cost sharing model to their Board which was heard at the September 19, 2019 AUSD Board meeting.

On September 24, 2019, the City Council approved a Memorandum of Understanding (MOU) for the reimbursement of crossing guard services with RUSD and AUSD for a five-year term through June 30, 2024.

On February 27, 2024, Council approved the Second Amendment to the Professional Consultant Services Agreement for Crossing Guard Program Management Services with ACMS, to add twelve (12) guard locations at AUSD and 1 guard location at RUSD location through June 30, 2024, approved the First Amendment to Memorandum of Understanding between the AUSD to add 12 additional guard sites at a 100% reimbursement to the City of Riverside for the addition of the new guard sites of Crossing Guard Services, and authorized to pay \$13,500 for Crossing Guard Services for the St. Catherine of Alexandria site at Arlington and Brockton for the remainder of the 2023/24 school year. This MOU change allowed AUSD to leverage the City of Riverside's lower pricing for crossing guard services.

On June 18, 2024, Council approved the Third Amendment to the Professional Consultant Services Agreement with ACMS, for Crossing Guard Program Management Services, to add seven (7) additional guard locations for a total of 84 guard locations through June 30, 2026, approved the First Amendment to MOU between RUSD to add six (6) additional guard locations in their district through June 30, 2025, approved the Third Amendment to the MOU between the AUSD for to add one (1) additional guard location in their district through June 30, 2025, and approved the MOU between the St. Catherine of Alexandria School for 100% reimbursement of Crossing Guard Services through June 30, 2026.

DISCUSSION:

The Memorandum of Understandings (MOU) with AUSD and RUSD are set to expire on June 30, 2025, and the Agreement with ACMS is currently in its sixth year and is set to expire on June 30, 2026. Currently, the City funds the originally contracted schools at 50%. Crossing guard services for newly contracted schools are being fully reimbursed by the respective school districts. Table 1 outlines the existing reimbursement schedule for the original school sites and those additional sites amended into the agreement.

Cost Sharing Options

During previous Council discussions related to Crossing Guard MOU amendments, the subject of continued adjustment to the cost sharing model was raised. In response to prior feedback, staff developed Table 2 which outlines several cost-sharing options for the Committee's consideration. Staff recommend the consideration of increasing the school district contributions for the original 64 schools by 5% each year over a five-year term, beginning in FY 2025/26, with the goal of reaching a 75% (School) / 25% (City) contribution split in 5 years. The proposed reimbursement schedule is listed in Table 2 – Option C. Under the recommended scenario, the cost for new crossing guard (not counting the reassignment of an existing guard) would be fully borne by the respective school districts.

A secondary consideration is for the City to maintain the existing Crossing Guard cost-sharing model for the next 5 years as listed in Table 2 – Option B.

On January 28, 2025, the City Manager and the Public Works Department met with representatives from RUSD and AUSD. During discussions, RUSD shared that they would like to add three crossing guard locations to the new school site at Casa Blanca Elementary with the request to pay no more than 50% as listed in Table 2 – Option D below, as the new school is within the City limits. This decision would set precedence for any additional sites, as Eastside Elementary will also require crossing guards and it is expected to open in 2027.

Lastly, the City could discontinue the program funding as listed in Table 2 – Option A as the crossing guard contract with ACMS is scheduled to sunset on June 30, 2026.

Works Department, RUSD, AUSD, and St. Catherine of Alexandria and demonstrates responsible management of the City's financial resources to provide quality public services and ensure partnering school districts achieve cost savings through our competitive pricing.

- 4. Innovation This item is neutral in this area.
- 5. **Sustainability & Resiliency** Maintaining service agreements allows the City of Riverside to meet the needs of the present without compromising the needs of the future and ensures the City's capacity to persevere, adapt and grow during good and difficult times alike.

FISCAL IMPACT:

The Fiscal Impact will be determined by the Option selected. The following table reflects estimated costs for the City and each school district for the Options outlined previously.
