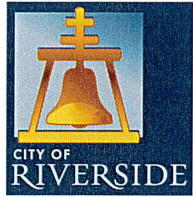
Chair Plascencia convened the meeting at 3:30 p.m.

REGULATION OPTIONS FOR AMENDMENTS TO RIVERSIDE MUNICIPAL CODE CHAPTER 5.36 REGARDING REGULATION OF MOBILE FOOD VENDORS

Following discussion, it was moved by Vice Chair Fierro and seconded by Member Edwards to direct staff to (1) recommend that City Council make a determination regarding Hours of Operation as indicated in proposed Riverside Municipal Code (RMC) Section 5.36.065 regarding mobile food vendors; (2) recommend that a review of the program is implemented after one year to discuss potential issues and regulations; (3) conduct additional vetting with regards to questions about the Business Improvement District (BID) and whether there can be language on inclusion of mobile food vendors within a BID ; (4) prepare options for an ordinance that (a) adds provisions regarding private property; (b) amends language in RMC Section 5.36.010 (A); (c) clarifies alleys and streets; and (d) includes language to allow food trucks in parks and exclude the same parks as stated in proposed RMC Section 5.38.125(B) regarding street vendors; (5) conduct additional research pertaining to viability of food trucks in alleys; and (6) prepare proposed ordinance for City Council consideration. The motion carried unanimously.
