# City Council Memorandum

**SUBJECT: PURCHASE OF FIVE REPLACEMENT VEHICLES AT A TOTAL COST OF \$100,657.63**

## **ISSUE:**

Approval of a purchase order to Raceway Ford for five (5) replacement vehicles, in accordance with Purchasing Resolution 22576 Section 201(g), at a total cost of \$100,657.63.

## **RECOMMENDATION:**

That the City Council approve the issuance of a purchase order to Raceway Ford of Riverside, California, for the purchase of four (4) 2016 Ford Fusion sedans and one (1) 2015 Ford Taurus sedan in the amount of \$100,657.63 in accordance with Purchasing Resolution 22576 Section 201(g).

## **BACKGROUND:**

On October 21, 2014, the City Council approved the award of Bid No. 7279 to Raceway Ford for the purchase of twenty (20) 4-door all-wheel drive police interceptor SUV pursuit vehicles, twenty-five (25) Ford Fusion sedans, five (5) Ford Taurus sedans and one (1) Ford Explorer SUV. Purchasing Resolution 22576, Section 201(g) states that competitive procurement shall not be required when goods or services can be procured from a Contractor who offers the same or better price, terms and conditions as the contractor previously offered as the lowest responsible bidder under competitive procurement or negotiations conducted by the City or another public agency, provided that, in the opinion of the Purchasing Services Manager, it is in the best interests of the City to do so. The Purchasing Services Manager believes that it is in the City's best interest to purchase two additional vehicles; (4) 2016 Ford Fusion sedans and one (1) 2015 Ford Taurus sedan from Raceway Ford, at the agreed upon pricing and that this purchasing resolution applies.

Raceway Ford has agreed to honor the same pricing for four (4) 2016 Ford Fusion sedans and one (1) 2015 Ford Taurus sedan for a total cost of \$100,657.63 for all five vehicles.

The Purchasing Services Manager concurs with the recommendation.

**FISCAL IMPACT:**

Sufficient funds in the amount of \$100,657.63 are available in the Police Department's budget Account No. 3105000-462100.
