

## **SERVICES AGREEMENT**

### **INNOVATIVE DESIGN AND SHEET METAL PRODUCTS, INC. dba INNOVATIVE EMERGENCY EQUIPMENT**

#### **Specialty Vehicle Equipment, Removal, and Installation Services**

On this \_\_\_\_ day of \_\_\_\_\_, 20 \_\_, the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and INNOVATIVE DESIGN AND SHEET METAL PRODUCTS, INC., a Delaware corporation authorized to do business in California, doing business as INNOVATIVE EMERGENCY EQUIPMENT ("Contractor"), mutually agree as follows:

1. **Scope of Services.** Contractor shall furnish all labor, materials and equipment for and perform the work of Specialty Vehicle Equipment, Removal, and Installation Services ("Services"). Contractor shall perform the Services in accordance with the provisions and requirements of the Scope of Services attached hereto as Exhibit "A" and incorporated herein by reference.

2. **Term.** This Agreement shall be in effect until September 30, 2029, unless otherwise terminated pursuant to the provisions herein.

3. **Compensation.** City shall pay Contractor for the performance of the Services during the initial term of this Agreement an annual sum not to exceed Five Hundred Thousand Dollars (\$500,000), except that for the remainder of FY 24/25 the compensation shall not exceed Four Hundred Sixty-Three Thousand Nine Hundred Fifty-Eight Dollars and Forty-Eight Cents (\$463,958.48), for a total contract amount not to exceed Two Million Four Hundred Sixty-Three Thousand Nine Hundred Fifty-Eight Dollars and Forty-Eight Cents (\$2,463,958.48), unless an increase is agreed to by the parties. City shall pay Contractor for Services performed to City's satisfaction on a monthly basis in accordance with the provisions of the Compensation Schedule attached hereto as Exhibit "B" and incorporated herein by this reference. If the term of the Agreement is extended, Contractor's compensation for the extended term shall be mutually agreed upon in writing by the parties.

4. **General Compliance with Laws.** Contractor shall keep fully informed of federal, state and local laws and ordinances and regulations which in any manner affect those employed by Contractor, or in any way affect the performance of Services by Contractor pursuant to this Agreement. Contractor shall at all times observe and comply with all such laws, ordinances and regulations, and shall be solely responsible for any failure to comply with all applicable laws, ordinances and regulations.

5. **Business Tax Certificate.** As a condition of this Agreement, Contractor shall secure a business tax certificate to operate in the City of Riverside pursuant to Chapter 5.04 of the Riverside Municipal Code, and shall also secure any other licenses or permits which may be required.

6. **Business Tax and Penalties.** Contractor acknowledges and agrees that with respect to any business tax or penalties thereon, utility charges, invoiced fee or other debt which is owed, or which becomes owed, by Contractor to City, City reserves the right to withhold and offset said amounts from any payments, refunds or reimbursements owed by City to Contractor under the Agreement. Notice of such withholding and offset shall promptly be given to Contractor by City in writing. In the event of a dispute as to the amount owed or whether such amount is owed to City, City will hold such disputed amount until either the appropriate appeal process has been completed or until the dispute has been resolved.

7. **Personnel.** Contractor shall furnish all personnel necessary to perform the Services and shall be responsible for their performance and compensation. The key personnel are listed in Exhibit "C," attached hereto and incorporated herein by reference. Contractor shall furnish qualified personnel to perform the Services.

8. **Assignment and Subcontracting.** Neither party shall assign any right, interest, or obligation in or under this Agreement to any other entity without prior written consent of the other party. In any event, no assignment shall be made unless the assignee expressly assumes the obligations of assignor under this Agreement, in a writing satisfactory to the parties. Contractor acknowledges that any assignment may, at the City's sole discretion, require City Manager and/or City Council approval. Contractor shall not subcontract any portion of the work required by this Agreement without prior written approval by the responsible City Contract Administrator. Subcontracts, if any, shall contain a provision making them subject to all provisions stipulated in this Agreement, including without limitation, the insurance obligations set forth in Section 11. The Contractor acknowledges and agrees that the City is an intended beneficiary of any work performed by any subcontractor for purposes of establishing a duty of care between any subcontractor and the City.

9. **Independent Contractor.** In the performance of this Agreement, Contractor, and Contractor's employees, subcontractors and agents, shall act in an independent capacity as independent contractors, and not as officers or employees of the City of Riverside. Contractor acknowledges and agrees that the City has no obligation to pay or withhold state or federal taxes or to provide workers' compensation or unemployment insurance to Contractor, or to Contractor's employees, subcontractors and agents. Contractor, as an independent contractor, shall be responsible for any and all taxes that apply to Contractor as an employer.

10. **Indemnification.** Except as to the sole negligence or willful misconduct of the City, Contractor shall indemnify and hold harmless the City, and the City's employees, officers, managers, agents and council members from any liability, claim, damage or action whatsoever, to the extent it is based or asserted upon any wrongful act or omission of Contractor, its officers, employees, subcontractors, agents or representatives, or arises out of or in any way relates to this agreement including but not limited to property damage, bodily injury, or death. Contractor shall defend, at its sole cost and expense, including but not limited to attorney fees, cost of investigation, defense and settlement or awards, the City and the City's employees, officers, managers, agents and council members in any such action or claim. With respect to any action or claim subject to indemnification herein by Contractor, Contractor shall, at its sole cost, have the right to use counsel of its own choice and shall have the right to adjust, settle, or compromise any such action or claim without the prior

consent of City; provided, however, that any such adjustment, settlement or compromise in no manner whatsoever limits or circumscribes Contractor's indemnification of City. Contractor's obligations hereunder shall be satisfied when Contractor has provided to City the appropriate form of dismissal (or similar document) relieving the City from any liability for the action or claim involved. The specified insurance limits required in this Agreement shall in no way limit or circumscribe Contractor's obligations to indemnify and hold harmless the City.

## **11. Insurance.**

11.1 General Provisions. Prior to the City's execution of this Agreement, Contractor shall provide satisfactory evidence of, and shall thereafter maintain during the term of this Agreement, such insurance policies and coverages in the types, limits, forms and ratings required herein. The rating and required insurance policies and coverages may be modified in writing by the City's Risk Manager or City Attorney, or a designee, unless such modification is prohibited by law.

11.1.1 Limitations. These minimum amounts of coverage shall not constitute any limitation or cap on Contractor's indemnification obligations under Section 10 hereof.

11.1.2 Ratings. Any insurance policy or coverage provided by Contractor or subcontractors as required by this Agreement shall be deemed inadequate and a material breach of this Agreement, unless such policy or coverage is issued by insurance companies authorized to transact insurance business in the State of California with a policy holder's rating of A or higher and a Financial Class of VII or higher.

11.1.3 Cancellation. The policies shall not be canceled unless thirty (30) days' prior written notification of intended cancellation has been given to City by certified or registered mail, postage prepaid.

11.1.4 Adequacy. The City, its officers, employees and agents make no representation that the types or limits of insurance specified to be carried by Contractor pursuant to this Agreement are adequate to protect Contractor. If Contractor believes that any required insurance coverage is inadequate, Contractor will obtain such additional insurance coverage as Contractor deems adequate, at Contractor's sole expense.

11.2 Workers' Compensation Insurance. By executing this Agreement, Contractor certifies that Contractor is aware of and will comply with Section 3700 of the Labor Code of the State of California requiring every employer to be insured against liability for workers' compensation, or to undertake self-insurance before commencing any of the work. Contractor shall carry the insurance or provide for self-insurance required by California law to protect said Contractor from claims under the Workers' Compensation Act. Prior to City's execution of this Agreement, Contractor shall file with City either 1) a certificate of insurance showing that such insurance is in effect, or that Contractor is self-insured for such coverage, or 2) a certified statement that Contractor has no employees, and acknowledging that if Contractor does employ any person, the necessary certificate of insurance will immediately be filed with City. Any certificate filed with City shall provide that City will be given ten (10) days' prior written notice before modification or cancellation thereof.

11.3 Commercial General Liability and Automobile Insurance. Prior to City's execution of this Agreement, Contractor shall obtain, and shall thereafter maintain during the term of this Agreement, commercial general liability insurance and automobile liability insurance as required to insure Contractor against damages for personal injury, including accidental death, as well as from claims for property damage, which may arise from or which may concern operations by anyone directly or indirectly employed by, connected with, or acting for or on behalf of Contractor. The City, and its officers, employees and agents, shall be named as additional insureds under the Contractor's insurance policies.

11.3.1 Contractor's commercial general liability insurance policy shall cover both bodily injury (including death) and property damage (including, but not limited to, premises operations liability, products-completed operations liability, independent contractor's liability, personal injury liability, and contractual liability) in an amount not less than \$1,000,000 per occurrence and a general aggregate limit in the amount of not less than \$2,000,000.

11.3.2 Contractor's automobile liability policy shall cover both bodily injury and property damage in an amount not less than \$1,000,000 per occurrence and an aggregate limit of not less than \$1,000,000. All of Contractor's automobile and/or commercial general liability insurance policies shall cover all vehicles used in connection with Contractor's performance of this Agreement, which vehicles shall include, but are not limited to, Contractor owned vehicles, Contractor leased vehicles, Contractor's employee vehicles, non-Contractor owned vehicles and hired vehicles.

11.3.3 Prior to City's execution of this Agreement, copies of insurance policies or original certificates along with additional insured endorsements acceptable to the City evidencing the coverage required by this Agreement, for both commercial general and automobile liability insurance, shall be filed with City and shall include the City and its officers, employees and agents, as additional insureds. Said policies shall be in the usual form of commercial general and automobile liability insurance policies, but shall include the following provisions:

It is agreed that the City of Riverside, and its officers, employees and agents, are added as additional insureds under this policy, solely for work done by and on behalf of the named insured for the City of Riverside.

11.3.4 The insurance policy or policies shall also comply with the following provisions:

a. If the policy is written on a claims made basis, the certificate should so specify and the policy must continue in force for one year after completion of the services. The retroactive date of coverage must also be listed.

b. The policy shall specify that the insurance provided by Contractor will be considered primary and not contributory to any other insurance available to the City and Endorsement No. CG 20010413 shall be provided to the City.

12. **Termination.** City shall have the right to terminate any or all of Contractor's Services and work covered by this Agreement at any time upon thirty (30) calendar days' written notice to Contractor. In the event of such termination, Contractor shall submit Contractor's final written statement of the amount of services provided as of the date of such termination for payment by the City.

Notwithstanding the foregoing, the City may terminate Contractor's performance of this Agreement upon five (5) calendar days' written notice if:

- (1) Contractor fails to promptly begin performance of the Services;
- (2) Contractor fails to perform the Services;
- (3) Contractor discontinues performance of the Services;
- (4) Contractor fails to make payment to employees in accordance with applicable law;
- (5) Contractor disregards laws, ordinances, or rules, regulations, or orders of a public authority having jurisdiction;
- (6) Contractor otherwise is guilty of breach of a provision of this Agreement;
- (7) Contractor becomes insolvent, is adjudicated bankrupt, or makes a general assignment for the benefit of creditors and fails to provide City with adequate assurances of Contractor's ability to satisfy its contractual obligations.
- (8) A receiver, trustee, or other judicial officer shall not have any right, title, or interest in or to this Agreement. Upon that person's appointment, City has, at its option and sole discretion, the right to immediately cancel the Agreement and declare it null and void.

13. **Non-Discrimination.** During Contractor's performance of this Agreement, Contractor shall not discriminate on the grounds of race, religious creed, color, national origin, ancestry, age, physical disability, mental disability, medical condition including the medical condition of Acquired Immune Deficiency Syndrome (AIDS) or any condition related thereto, marital status, gender, gender identity, genetic information, gender expression, sex or sexual orientation, military and veteran status, in the selection and retention of employees and subcontractors and the procurement of materials and equipment, except as provided in Section 12940 of the California Government Code. Further, Contractor agrees to conform to the requirements of the Americans with Disabilities Act in the performance of this Agreement.

14. **City's Right to Employ Other Consultants/Contractors.** City reserves the right to employ other Contractors in connection with the Services. If the City is required to employ another contractor to complete Contractor's work, due to the failure of the Contractor to perform,

or due to the breach of any of the provisions of this Agreement, the City reserves the right to seek reimbursement from Contractor.

15. **Conflict of Interest.** Contractor, for itself and on behalf of the individuals listed in Exhibit "C", represents and warrants that by the execution of this Agreement, they have no interest, present or contemplated, affected by the above-described Services. Contractor further warrants that neither Contractor, nor the individuals listed in Exhibit "C" have any real property, business interests or income interests that will be affected by this project or, alternatively, that Contractor will file with the City an affidavit disclosing any such interest.

16. **Solicitation.** Contractor warrants that Contractor has not employed or retained any person or agency to solicit or secure this Agreement, nor has it entered into any agreement or understanding for a commission, percentage, brokerage, or contingent fee to be paid to secure this Agreement. For breach of this warranty, City shall have the right to terminate this Agreement without liability and pay Contractor only for the value of work Contractor has actually performed, or, in its sole discretion, to deduct from the Agreement price or otherwise recover from Contractor the full amount of such commission, percentage, brokerage or commission fee. The remedies specified in this section shall be in addition to and not in lieu of those remedies otherwise specified in this Agreement.

17. **Prevailing Wage.** If applicable, pursuant to Section 1771 of the California Labor Code, Contractors are required to pay the general prevailing rates of per diem wages, overtime and holiday wages as determined by the Director of the Department of Industrial Relations and implemented by Resolution No. 13346 of the City Council of the City of Riverside. The Director's determination of prevailing wage rates is available on-line at [www.dir.ca.gov/dlsr/DPreWageDetermination.htm](http://www.dir.ca.gov/dlsr/DPreWageDetermination.htm), and is referred to and made a part hereof as though fully set forth herein. Contractor is aware of and stipulates that Contractor will also comply with California Labor Code Sections 1725.5 and 1771.1 requiring all general contractors and subcontractors to be registered with DIR, when applicable. Registration can be accomplished through the DIR website by using this link: <http://www.dir.ca.gov/PublicWorks/PublicWorks.html>.

18. **Notices.** Service of any notices, bills, invoices or other documents required or permitted under this Agreement shall be sufficient if sent by one party to the other by United States mail, postage prepaid and addressed as follows:

19. **Venue.** Any action at law or in equity brought by either of the parties hereto for the purpose of enforcing a right or rights provided for by this Agreement shall be tried in the

Superior Court of California, County of Riverside and the parties hereby waive all provisions of law providing for a change of venue in such proceedings to any other county.

20. **Waiver.** No action or failure to act by the City shall constitute a waiver of any right or duty afforded City under this Agreement, nor shall any action or failure to act constitute an approval of or acquiescence in any breach thereunder, except as may be specifically provided in this Agreement or as may be agreed in writing.

21. **Severability.** Each provision, term, condition, covenant and/or restriction, in whole and in part, in this Agreement shall be considered severable. In the event any provision, term, condition, covenant and/or restriction, in whole and/or in part, in this Agreement is declared invalid, unconstitutional, or void for any reason, such provision or part thereof shall be severed from this Agreement and shall not affect any other provision, term, condition, covenant and/or restriction of this Agreement and the remainder of the Agreement shall continue in full force and effect.

22. **Amendments.** This Agreement may be modified or amended only by a written agreement and/or change order executed by the Contractor and City.

23. **Authority.** The individuals executing this Agreement and the instruments referenced herein on behalf of Contractor each represent and warrant that they have the legal power, right and actual authority to bind Contractor to the terms and conditions hereof and thereof.

24. **Entire Agreement.** This Agreement constitutes the final, complete, and exclusive statement of the terms of the agreement between the parties pertaining to the subject matter of this Agreement, and supersedes all prior and contemporaneous understandings or agreements of the parties. Neither party has been induced to enter into this Agreement by, and neither party is relying on, any representation or warranty outside those expressly set forth in this Agreement.

25. **Digital and Counterpart Signatures.** Each party to this Agreement intends and agrees to the use of digital signatures that meet the requirements of the California Uniform Electronic Transactions Act (Civil Code §§ 1633.1, et seq.), California Government Code § 16.5, and California Code of Regulations Title 2 Division 7 Chapter 10, to execute this Agreement. The parties further agree that the digital signatures of the parties included in this Agreement are intended to authenticate this writing and to have the same force and effect as manual signatures for purposes of validity, enforceability, and admissibility. For purposes of this section, a “digital signature” is defined in subdivision (d) of Section 16.5 of the Government Code and is a type of “electronic signature” as defined in subdivision (h) of Section 1633.2 of the Civil Code. This Agreement may be executed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument. Each certified or authenticated electronic copy of an encrypted digital signature shall be deemed a duplicate original, constituting one and the same instrument and shall be binding on the parties hereto.

26. **Interpretation.** City and Contractor acknowledge and agree that this Agreement is the product of mutual arms-length negotiations and accordingly, the rule of construction, which

provides that the ambiguities in a document shall be construed against the drafter of that document, shall have no application to the interpretation and enforcement of this Agreement.

26.1 Titles and captions are for convenience of reference only and do not define, describe or limit the scope or the intent of the Agreement or any of its terms. Reference to section numbers, are to sections in the Agreement unless expressly stated otherwise.

26.2 This Agreement shall be governed by and construed in accordance with the laws of the State of California in effect at the time of the execution of this Agreement.

26.3 In the event of a conflict between the body of this Agreement and Exhibit "A" - Scope of Services hereto, the terms contained in Exhibit "A" shall be controlling.

27. **Exhibits.** The following exhibits attached hereto are incorporated herein to this Agreement by this reference:





**SCOPE OF SERVICES**

## Scope of Work

Law enforcement upfit services involves the customization and outfitting of vehicles to meet the specific needs of the City of Riverside (City), Riverside Police Department (RPD). RPD requires the installation of specialized equipment in their vehicles to include, but not be limited to, lights, sirens, communication systems, storage solutions for weapons and other gear. Innovative Design and Sheet Metal Products (Contractor) must maintain the following qualifications throughout the term of the Agreement. This Scope of Work is based on the County of Riverside Contract ID# SHARC-05516-010-10/29 dated October 1, 2024

### QUALIFICATIONS

1. The Contractor will provide equipment, equipment installation and removal services as requested by RPD or the City of Riverside General Services Department Fleet Services Division (Fleet Services) on the RPDs behalf for all active service vehicles. The RPD and/or Fleet Services will order products that are identified in the Parts List for Each Vehicle Type Build (Parts List) contained herein. The Parts List is a list of approved items to be installed in the RPD vehicles. The Contractor shall be required to provide product usage reports to RPD and Fleet Services upon request. The Contractor shall be responsible for stocking and providing the product inventory for the standard vehicle types listed in the Parts List, manpower resources, and/or production equipment necessary to meet the intent of this agreement. The Contractor shall also be responsible for maintenance repairs on installed upfit equipment.
  - a. The RPD will have the awarded Contractor build patrol, stealth, and plain vehicles for fiscal years 2024/25 through 2028/29. Other current car types are as follows:
    - i. Ford Utility Interceptor
    - ii. Ford Utility Interceptor Stealth Cars
    - iii. Ford Expedition Patrol Cars
    - iv. For Expedition Stealth Cars
    - v. Chevrolet Tahoe PPV Patrol Cars
    - vi. Ford F-150 Responder
  - b. The City does not guarantee any amount of business to any Contractor.
  - c. The City may evaluate other possible future patrol vehicles at the discretion of the RPD.
  - d. Adding to these numbers are "Specialty Vehicles" that the RPD will need from time to time, such as the following:
    - i. Patrol K-9 adaptations

- ii. Forensic Trucks
    - iii. Bomb Squad Vehicles
  - e. The Contractor will not be required to have inventory on hand for these specialty vehicles.
  - f. The City does not guarantee any amount of business to any Contractor
2. The Contractor will be required to strip parts from a combination of patrol, stealth, and plain vehicles. The Contractor will be required to strip non-drivable vehicles (out of service & collision totals) at the City of Riverside Police Station located at 8181 Lincoln Avenue, Riverside, CA 92504.
3. Vehicle Strips may include, but not be limited to, the removal of:
- a. All emergency lighting equipment and sirens
  - b. Police radio, scanner, and tablets/MDC
  - c. Partition cages or K-9 kennels
  - d. All gun racks
  - e. Metal trunk boxes and trays
  - f. Fire extinguisher
  - g. Rear plastic seat and seat belts
4. The Contractor should note that any additional equipment requested outside of approved list must be reviewed and approved by the RPD Field Operations Captain. The RPD will not process payment for additional work that is not authorized by the RPD Field Operations Captain.
5. Some equipment and commodities that the RPD may not acquire from the Contractor are items that would be construed as a firearm (weapon) or the ammunition and accessories for such firearms and equipment.
6. Expectations of the Contractor:
- a. The Contractor will make arrangements with RPD or Fleet Services for pick-up once vehicle is completed.
  - b. The Contractor will "strip-out" such retired vehicles as presented by RPD or Fleet Services personnel.
  - c. The Contractor shall be provided with a Work Order from RPD or Fleet Services for all vehicle build packages before any work can commence.
  - d. The RPD and Fleet Services shall be contacted via email for approval of all requests outside of any standard build package. E-mail addresses will be provided to the Contractor upon execution of this Agreement.

- e. All repair invoices submitted for payment shall include a copy of the Contractor service/work order that lists the requested reason for service (with the exception of invoices with Work Orders).
- 7. Pricing will be all specific to the vehicle equipment and labor, including shipping charges received for parts from third party vendors, strip charges and/or travel fees associated with the vehicle builds issued by the RPD. All charges must be clearly identified on invoices submitted for payment.
- 8. The Contractor shall notify the RPD and Fleet Services when an item is discontinued, substitutes are subject to prior review and written approval by the City.
  - a. Inventory and Special Equipment:
    - i. The Contractor shall stock inventory to complete five (5) installs at any given time, provide equipment, and train personnel, at the local installation locations, to support the volume of vehicles the RPD requires to maintain its operations and fleet levels. Minimum expectation is five (5) complete kits for standard black and white patrol vehicles. If the City makes a change, the Contractor shall use up all current inventory first.
- 9. The Contractor shall be required to have access to a custom fabrication shop that would allow for the many and various vehicle builds and subsequent installations that arise from various needs and specialty configurations of the Department.
- 10. The Contractor shall have made or cause to have made for them a "one-piece electrical wiring harness" to be installed in the RPDs vehicles to maintain consistency in installation of equipment and ease in trouble shooting electrical problems. NO EXCEPTION.
- 11. EQUIPMENT: The RPD reserves the right to have equipment/parts installed that are of equal design, form, fit, and function. The RPD reserves the right to specify or make changes on equipment for the duration of the Agreement.

## MINOR REPAIR INSTRUCTIONS

### A. Minor Repair:

- a. The Contractor shall prepare a detailed written estimate upon completion of the inspection process. This report shall provide an estimate of cost and time for recommended work. The estimate shall list parts, labor (hours and rate), sublet work (if applicable), any miscellaneous charges (with explanation), and tax.
- b. The Contractor shall furnish the facility and all necessary supervision, labor, tools, vehicle manuals, and supplies required to provide the repairs and service to all vehicles.
- c. The Contractor shall be responsible for vehicles accepted for repair. Responsibility entails ensuring reasonable steps are taken to secure vehicles and contents from theft and vandalism.
- d. Incidents of theft or vandalism to City vehicles in the Contractor's care must be reported to the RPD immediately and the Contractor shall notify and report theft/vandalism to local law enforcement in the event it occurs outside of the City of Riverside. The Contractor may be held liable for the replacement/repair of vehicles damaged or missing equipment while under the control of the Contractor.
- e. The RPD shall have the right at all times to inspect or otherwise evaluate the work being performed and parts or equipment used by the Contractor. The RPD reserves the right to reject materials and workmanship, at City's sole discretion, to be unacceptable. The Contractor shall immediately remedy unacceptable workmanship at no expense to the City.

### B. Operational Specifications:

- a. The Contractor shall immediately consult with the RPD and Fleet Services to identify all contracted vehicle service equipment/parts that will be stocked at their local installer's location. This shall be accomplished within the manufacturing standard lead times which will vary at the time of the award and prior to the actual commencement of the agreement date. This action shall also repeat itself every year and prior to the renewal of the contract during the award period. This is necessary to adjust for rolling stock changes within the RPD. By mutual agreement, between the parties, a ready inventory of installable equipment/parts shall be determined using expected weekly production output based on monthly or yearly usable vehicle installation expectations.

- b. The Contractor shall have committed to the "Maximum" production/delivery time required to complete the required number of vehicle installations. The Contractor shall complete a single vehicle installation in five (5) business days. The Contractor shall commit to a service satisfaction level of 95% and to make the necessary investment in "on-hand inventory or equipment/parts" and service personnel to maintain this account. The Contractor shall monitor their local and back-up inventories on a regular basis and coordinate their replenishment orders with the supplying factory to take into account lead times and production schedules, and sales to other user agencies, and to ensure that the RPD shall be serviced in a manner that justifies the dollar amount of this Agreement.
  - i. The Contractor will provide an estimated time of completion of work for all types of build outs listed.
  - ii. Should it be determined that the Contractor has not made the necessary commitment to service and inventory stocking levels, as demonstrated by poor service to the RPD, a 30-day notice to rescind the balance of this award shall and will be issued by the RPD or Fleet Services. Frequent late deliveries of completed vehicle installations or consistent failure to meet delivery promises without valid reason shall result in cancellation of the entire award/agreement and/or removal from the bid list.
- c. DELAYS: If a delay is foreseen in the availability of any part, an accessory (of any type), or piece of equipment required to complete the vehicle installation as ordered by the RPD/Fleet Services or any of the above items that are normally considered an "In-Stock" inventory item, the Contractor shall give thirty (30) days prior written notice to the RPD and Fleet Services. This notice shall detail the exact nature of the delay and the date the item will be either received by the Contractor or will be available in inventory and ready for installation. The RPD/Fleet Services has the right to extend the delivery due date if reasons appear, in the sole discretion of the RPD/Fleet Services, to be valid. The Contractor must keep the RPD/Fleet Services advised at all times of the status delay. Default in "promised delivery" (without acceptable reasons) or failure to meet specifications, authorizes the RPD/Fleet Services to purchase the parts, accessories, or equipment elsewhere and charge full increase in cost and handling to the defaulting Contractor.
  - i. A weekly progress report detailing the production status of all vehicles assigned to the vendor will be sent via E-mail to RPD and Fleet Services. E-mail addresses will be provided to the Contractor upon execution of this Agreement.

- d. SPECIAL REQUESTS: The Contractor shall notify the RPD Field Operations Captain in the event that additional equipment is being requested by RPD personnel outside of the scope of work. All authorization for additional equipment must be provided by the RPD Field Operations Captain.
- e. EQUIPMENT PICK-UP: The Contractor shall notify the RPD and Fleet Services only after the required equipment has been completely and successfully installed in the previously delivered City vehicle; and that this vehicle has successfully completed and passed functionality testing of the installed equipment prior to pick-up. A delivery/check-out form, for each vehicle, shall also have been prepared, annotated, and ready for the vehicle pick-up inspection. It shall be agreed to by the awarded Contractor that the time allotted to the delivery/inspection procedure is of the essence.
- f. INSTALLATION LOCATION: The RPD and Fleet Services are located in the metropolitan area of Riverside, California. Therefore, it is the RPDs preference that the Contractor installation site be located within this area. If located "out-of-the-area," the Contractor will be responsible for transporting all vehicles to and from the City of Riverside Police Station located at 8181 Lincoln Avenue, Riverside, California 92504 or to Fleet Services located at the City of Riverside Corporation Yard at 8095 Lincoln Avenue, Riverside, California 92504.
- g. SERVICE CENTER: The Contractor should have the ability and experience to service Emergency Vehicle Lighting Equipment upon commencement of the Agreement. While the Contractor is not required to be an authorized manufacture warranty repair center, it is expected that the Contractor will handle all warranty claims.
