

**FIRST AMENDMENT
TO THE AGREEMENT FOR ANIMAL FIELD AND SHELTER SERVICES BETWEEN
THE CITY OF RIVERSIDE AND THE COUNTY OF RIVERSIDE**

This FIRST AMENDMENT TO THE AGREEMENT FOR ANIMAL FIELD AND SHELTER SERVICES (“First Amendment”) is made and entered into this ____ day of _____, 2026, by and between the COUNTY OF RIVERSIDE, a political subdivision of the State of California (“County”), and the CITY OF RIVERSIDE, a Charter City and Municipal Corporation (“City”); together known as the “parties,” and individually as a “party,” with reference to the following facts:

RECITALS

WHEREAS, on or about December 9, 2025, County and City entered into that certain Agreement for Animal Field and Shelter Services (“Agreement”) that was ratified and made effective July 1, 2025 through June 30, 2028; and

WHEREAS, County and City agree that the County will not charge the City of Riverside for meeting time with the Department of Animal Services; and

WHEREAS, County and City desire to amend the Agreement to revise Section III and Exhibit B accordingly.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties mutually agree as follows:

1. **Recitals.** The above recitals are true and correct and incorporated herein by reference.

2. **Section III.** Subsections D and E of Section III, “Performance of Contract,” of the Agreement are hereby deleted and replaced to read as follows:

“D. If requested, the COUNTY will make its best efforts to attend one (1) in-person meeting with CITY, up to three (3)-hour duration per quarter. Additional meetings may be scheduled under unusual or urgent circumstances as agreed upon by the COUNTY. Due to lack of availability of meeting space in COUNTY facilities, the CITY will provide a mutually agreed upon meeting space and location, or virtual meeting link for virtual meetings. **COUNTY shall not charge CITY for meeting time with the Department of Animal Services.**

E. If requested, the COUNTY will make its best efforts to coordinate a virtual meeting once per month at no charge to CITY. Additional meetings may be scheduled under unusual or urgent circumstances as agreed upon by the COUNTY. **COUNTY shall**

not charge CITY for meeting time with the Department of Animal Services.”

3. Exhibit B. Attachment B to Exhibit B of the Agreement is hereby deleted and replaced in its entirety with Attachment B-1, attached hereto and incorporated in the Agreement by this reference.

4. Miscellaneous. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect and are hereby incorporated by reference into this First Amendment as though set forth in full herein.

5. Effective Date. This First Amendment shall be effective upon signature of the parties.
