

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING APPROXIMATELY 0.81 ACRES OF PROPERTY LOCATED AT 4440 AND 4468 BROCKTON AVENUE FROM DSP-AS – DOWNTOWN SPECIFIC PLAN – ALMOND STREET DISTRICT OVERLAY ZONE TO RCHSP – RIVERSIDE COMMUNITY HOSPITAL SPECIFIC PLAN OVERLAY ZONE.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is amended by removing from the DSP-AS Downtown Specific Plan – Almond Street District Overlay Zone and placing in the RCHSP – Riverside Community Hospital Specific Plan Overlay Zone, the approximately 0.81 acres of property located at 4440 and 4468 Brockton Avenue, generally situated on the southeast corner of Brockton Avenue and 14th Street, identified as Assessor’s Parcel Nos. 217-060-020 and 217-060-009, as described and depicted in Exhibit “A” and Exhibit “B” attached hereto and incorporated herein by this reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case Number PR-2024-001701, which conditions, restrictions and covenants are incorporated herein by reference.

Section 2: The City Clerk shall certify to the adoption of this Ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This Ordinance shall become effective on the 30th day after the date of its adoption.

FROM: DOWNTOWN SPECIFIC PLAN-ALMOND STREET DISTRICT OVERLAY ZONE

THE LAND REFERRED TO HEREIN SITUATED IN THE CITY OF RIVERSIDE, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, BEING LOTS 6 THROUGH 10 AND THAT PORTION OF THE NORTHWESTERLY HALF OF THAT CERTAIN 10 FOOT ALLEY ADJACENT TO SAID LOTS ON THE SOUTHEAST, AS VACATED BY RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, A CERTIFIED COPY OF SAID RESOLUTION RECORDED ON JUNE 23, 1966 AS INSTRUMENT NO. 65087, OFFICIAL RECORDS, ALL IN B. EXCEPTING THEREFROM THE NORTHWESTERLY 4 FEET OF SAID LOTS 6 THROUGH 9, INCLUSIVE, LYING WITHIN BROCKTON AVENUE.


