

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, ESTABLISHING THE APPROPRIATIONS LIMIT FOR
4 FISCAL YEAR 2015-2016 FOR THE CITY OF RIVERSIDE IN
5 ACCORDANCE WITH THE PROVISIONS OF DIVISION 9 OF TITLE 1 OF
6 THE GOVERNMENT CODE OF THE STATE OF CALIFORNIA.

7 WHEREAS, Article XIII B of the Constitution of the State of California as proposed by
8 the Initiative Measure approved by the people at the special statewide election held on November
9 6, 1979, as amended by Proposition 111 approved on June 5, 1990, and operative July 1, 1990,
10 provides that the total annual appropriations subject to limitation of each local government shall
11 not exceed the appropriations limit of such entity for the prior year adjusted for the change in the
12 cost of living and the change in population except as otherwise specially provided for in said
13 Article; and

14 WHEREAS, the State Legislature added Division 9 (commencing with Section 7900) to
15 Title 1 of the Government Code of the State of California to implement Article XIII B of the
16 California Constitution; and

17 WHEREAS, Section 7902(b) of the Government Code sets forth the method for
18 determining the appropriations limit for each local jurisdiction; and

19 WHEREAS, Section 7910 of the Government Code provides that each year the
20 governing body of each local jurisdiction shall, by resolution, establish its appropriations limit
21 and make other necessary determinations for the following fiscal year pursuant to Article XIII B
22 at a regularly scheduled meeting or a noticed special meeting, and that fifteen days prior to such
23 meeting, documentation used in the determination of the appropriations limit and other necessary
24 determinations shall be available to the public; and

25 WHEREAS, the City Council of the City of Riverside wishes to establish the
26 appropriations limit for fiscal year 2015-2016 for the City of Riverside in accordance with the
27 provisions of Article XIII B of the Constitution and Sections 7900, *et seq.* of the Government
28 Code.

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
2 California, as follows:

3 Section 1: That is it hereby found and determined that the documentation used in the
4 determination of the appropriations limit for the City of Riverside for fiscal year 2015-2016 was
5 available to the public in the Finance Department of said City at least fifteen days prior to the
6 date of adoption of this resolution.

7 Section 2: That the Council of the City of Riverside elects to use the change in
8 California per capita income as the cost of living adjustment factor and the annual population
9 change for the City of Riverside as the population adjustment factor.

10 Section 3: That the City reserves the right to adjust or amend the appropriations limit
11 based upon the use of alternative growth factors as authorized by Proposition 111 if such
12 changes or revisions would result in a more advantageous appropriations limit, now or in the
13 future.

14 Section 4: That the appropriations limit of the City of Riverside for fiscal year 2015-
15 2016, as established in accordance with Sections 7902(b) and 7910 of the California Government
16 Code, shall be \$284,866,766.
