DISCUSSION CALENDAR

PERFORMANCE ASSESSMENT AND FINANCIAL EXPENDITURE REVIEW - CITY CLERK'S OFFICE
Following discussion and without formal motion, the City Council received and ordered filed a report from Arroyo Associates, Inc., regarding the performance assessment and financial expenditure review of the City Clerk's Office.

DEPARTMENT OF HOUSING AND HUMAN SERVICES - INTERFUND TRANSFER - SUPPLEMENTAL APPROPRIATION

Following discussion, it was moved by Councilmember Conder and seconded by Councilwoman Plascencia to (1) authorize the Chief Financial Officer, or designee to record a supplemental appropriation in the amount of \$503,944.82 in the General Fund accounts to be established by the Finance Department for the Department of Housing and Human Services; and (2) authorize the Chief Financial Officer, or designee, to record

an interfund transfer and appropriate funds in an estimated amount of \$10,120,000 from the existing Office of Homeless Solution Division, Housing Authority Division, and associated Community and Economic Development Department Division operating budgets to the appropriate funds and accounts as determined by the Finance Department for the Department of Housing and Human Services.

Mayor Lock Dawson returned to the meeting at this time and presided.

CONSENT CALENDAR

It was moved by Councilmember Hemenway and seconded by Councilmember Perry to approve the Consent Calendar as presented affirming the actions appropriate to each item. The motion carried unanimously.

The City Council designated Councilwoman Plascencia as the voting delegate and Mayor Lock Dawson as alternate for the Annual Business meeting of the 2023 League of California Cities Annual Conference and Expo held at the SAFE Credit Union Convention Center in Sacramento, on September 22, 2023.

BOARD AND COMMISSION APPOINTMENTS AND RESIGNATIONS

The City Council (1) appointed Aaron Agramon to the Human Relations Commission Citywide seat for a term through March 1, 2024; (2) appointed Rene Visco to the Commission of the Deaf Ward 1 seat for a term through March 1, 2025; (3) filed the resignation of Kathleen S. Barth from the Human Relations Commission Citywide seat; and (4) filed the resignation of Patty Binford from the Commission on Aging Citywide seat.

CEREMONIAL STREET NAME CHANGE FOR PRICE COURT IN HONOR OF THE WINEK FAMILY - RESOLUTION

The City Council approved the Mobility and Infrastructure Committee recommendation to adopt a resolution approving the ceremonial street name change of Price Court to Winek Court; whereupon, the title having been read and further reading waived, Resolution No. 24033 of the City Council of the City of Riverside, California, Approving the Ceremonial Street Name Change for Price Court, was presented and adopted.

RESCIND APPROVAL - PLANNING CASES P19-0560 CONDITIONAL USE PERMIT, P19-0561 VARIANCE, AND P19-0563 CERTIFICATE OF APPROPRIATENESS - PROPOSED HOTEL DEVELOPMENT FORMER CENTRAL FIRE STATION - 3420-3482 MISSION INN

The City Council (1) rescinded the determination that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the CEQA Guidelines, as the project will not have a significant effect on the environment; and (2) rescinded approval of Planning Cases P19-0560 (Conditional Use Permit), P19-0561 (Variance), and P19-0563 (Certificate of Appropriateness).

SERVICE EXTENSION - RIVERSIDE COUNTY ABANDONED VEHICLE ABATEMENT SERVICE AUTHORITY - RESOLUTION

The City Council (1) approved the continuation of the City's participation with the Riverside County Abandoned Vehicle Abatement Authority AVA Program; and (2) adopted the resolution authorizing the continuation of the service fee collected on behalf of the Riverside County Abandoned Vehicle Abatement Service Authority AVA Program through May 2034; whereupon, the title having been read and further reading waived, Resolution No. 24034 of the City Council of the City of Riverside, Authorizing the Extension of the Service Fee Collected on Behalf of the Riverside County Abandoned Vehicle Abatement Service Authority Until May 2034, was presented and adopted.

MASTER FRINGE BENEFITS AND SALARY PLAN AMENDMENT - CREATION OF NEW CLASSIFICATIONS AND SALARY RANGES - RESOLUTION

The City Council (1) approved the creation of the new classifications and salary ranges for the Housing and Human Services Director and the Deputy Housing and Human Services Director; (2) amended Section 15, Automobile Allowance and Reimbursement for Expenses, Table 7-Automobile Allowance to include the Housing and Human Services Director classification; (3) approved the salary alignment adjustment to the existing Principal Project Manager, Building Official, City Planner, and Economic Development Manager classifications; (4) approved the salary alignment adjustment and bargaining unit change to the existing Housing Authority Manager classification; and (5) adopted a Resolution amending the Master Fringe Benefits and Salary Plan to reflect the new classifications and salary ranges for the Housing and Human Services Director and the Deputy Housing and Human Services Director; to reflect the amendment to Section 15,

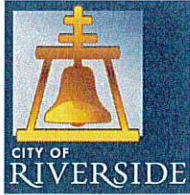
