
#### DEVELOPMENT AGREEMENT - CITYWIDE FIBER OPTIC NETWORK

Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway (1) to receive and file the report regarding the proposed Development Agreement with SiFi Networks Riverside, LLC, and the Committee provided feedback on the proposed agreement with SiFi Networks Riverside, LLC, for a Citywide Fiber Optic Network; and (2) recommending that the Innovation and Technology Department take the proposed Development Agreement between the City of Riverside and SiFi Networks Riverside, LLC, for a Citywide Fiber Optic Network to City Council for consideration.
