

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, OFFERING A REWARD IN THE AMOUNT
4 OF \$75,000 FOR INFORMATION LEADING TO THE DETERMINATION
OF THE IDENTITY OF, AND THE APPREHENSION OF, THE PERSON
OR PERSONS RESPONSIBLE FOR THE DEATHS OF JUAN ANTONIO
BARTOLO AND DOMINGO ESTEBAN.

5 WHEREAS, the City of Riverside may offer and pay rewards as authorized by Section
6 53069.5 of the Government Code of the State of California; and

7 WHEREAS, Section 53069.5 specifically authorizes the City to offer and pay a reward, the
8 amount thereof to be determined by the City for information leading to the determination of the
9 identify of, and the apprehension of, any person whose willful misconduct results in injury or death
10 to any person; and

11 WHEREAS, on March 20, 2001, the City Council adopted Resolution No. 19873 approving
12 the Riverside Police Department's Reward Program and authorizing its implementation; and

13 WHEREAS, on the evening of October 23, 2015, at the corner of 7th Street and Kansas
14 Avenue, decedents Juan Antonio Bartolo and Domingo Esteban were found on the ground suffering
15 from fatal gunshot wounds; and

16 WHEREAS, Mr. Bartolo was pronounced dead at the scene; and

17 WHEREAS, Mr. Esteban was transported to the hospital but did not survive; and

18 WHEREAS, investigators with the Riverside Police Department have worked tirelessly to
19 solve this unsolved crime; and

20 WHEREAS, investigators believe that there may be witnesses with information to this crime
21 who have not yet come forward; and

22 WHEREAS, the offer would be consistent with and is taken for the immediate protection of
23 public peace, health, and safety; and

24 WHEREAS, the offense was of such a nature or committed under special circumstances that
25 as a matter of public policy, the City of Riverside should provide a reward as an added inducement
26 or incentive for persons to come forth with information leading to the arrest of the perpetrator(s); and

27 WHEREAS, the offense was especially heinous, atrocious, or cruel and manifested
28 exceptional depravity.

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
2 California, that a reward in the amount of \$75,000 is hereby approved and authorized for
3 information leading to the determination of the identity of, and the apprehension of, any person
4 responsible for the acts stated above.

5 BE IT FURTHER RESOLVED that the offer of reward by the City shall be effective for a
6 period of sixty (60) days or for the term of any extension thereof which may be approved by the City
7 Council prior to the termination of the offer of reward. An offer of reward by the City shall terminate
8 by payment, by revocation, or by withdrawal thereof by the City Council by resolution, motion, or
9 council report adopted by a majority vote of the City Council or by expiration of the time period set
10 forth in the resolution offering the reward or any extension thereof which was approved by the City
11 Council while the offer was otherwise effective.

12 BE IT FURTHER RESOLVED that all decisions with respect to the relevance or materiality
13 of information received, whether or not utilized in establishing the determination of the identity of,
14 and the apprehension of, any one or more persons provides a basis for the payment of a reward, are
15 within the sole discretion of the City Council.

16 BE IT FURTHER RESOLVED that all determinations effective, or dispositive of the offer of
17 reward, shall be within the sole discretion of the City Council and shall be final.

18 BE IT FURTHER RESOLVED that pursuant to Section 53069.5, the person or persons
19 responsible for the deaths of Juan Antonio Bartolo and Domingo Esteban shall be liable for the
20 amount of any reward paid pursuant to this Section and if the person is an unemancipated minor, his
21 or her parent or guardian shall also be liable for the amount.
