## 311 AFTER-HOURS SERVICE

1. After-hours services available Mon. – Fri. from 6:00 p.m. to 7:00 a.m. & Saturdays/Sundays from 1:00 p.m. to 7:00 am the next business day.
2. New 3-1-1 Mobile App. link reported exact addresses to our four task force members from July 1<sup>st</sup> to 5<sup>th</sup>, between 5 PM till 7 AM.
3. 3-1-1 call taker will refer caller to contact 9-1-1 if it involves fire/life safety or call non-emergency line at 951-354-2007.
4. RFD and RPD issued 33 warning letters to any actual addresses retrieved from 3-1-1 and city council members on exact addresses using illegal fireworks.



## 311 FIREWORKS CALLS BY WARD



## ENHANCED 2020 FIREWORKS PROGRAM

1. New 311 Mobile App developed for specific task force members providing exact addresses of illegal fireworks activity.
2. Additional staffing was provided to support the task force operations on July 4th.
3. Social media outreach with branding of "Fireworks Are Illegal" image stating a \$1,000 fine would be issued.
4. Pub Ed Coordinator and Fire Marshal handed out posters to local businesses with open store fronts.
5. New PSA's and videos in English/Spanish, describing task force procedures when receiving and responding to 3-1-1 and 9-1-1 fireworks calls.
