
MINUTES


BY-LAWS AD HOC COMMITTEE



HUMAN RELATIONS COMMISSION STAFF UPDATES

Following the October 26, 2023, Human Relations Commission meeting, Principal Management Analyst Randy Solis provided updates regarding the workplan. The Human Relations Commission workplan was presented and approved by the subcommittee of council on January 10, 2024. The Human Relations Commission will be reviewing applications during the month of February. The elections of officers will take place during the month of March.

On February 24, 2024, at the Civil Rights Institute they will have Black History Month.
