2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ON
4 BEHALF OF THE CITY OF RIVERSIDE ALL NECESSARY
5 APPLICATIONS, CONTRACTS, PAYMENT REQUESTS, AGREEMENTS
6 AND AMENDMENTS IN THE PROCESS OF APPLYING FOR AND
SECURING FUNDS UNDER THE CALIFORNIA DEPARTMENT OF
RESOURCES RECYCLING AND RECOVERY (CALRECYCLE) FISCAL
YEAR 2015/16 BEVERAGE CONTAINER RECYCLING CITY/COUNTY
PAYMENT PROGRAM.

7 WHEREAS, pursuant to Public Resources Code section 40000 et seq., the Department of
8 Resource Recycling and Recovery (CalRecycle), is to administer various Grant Programs (“grants”)
9 in furtherance of the State of California’s (“State”) efforts to reduce, recycle and reuse solid waste
10 generated in the State thereby preserving landfill capacity and protecting public health and safety
11 and the environment; and

12 WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures
13 governing the application, awarding and management of the grants; and

14 WHEREAS, CalRecycle’s Beverage Container Recycling City/County Payment Program
15 application procedures require an applicant’s governing body to declare by resolution certain
16 authorizations related to the administration of CalRecycle grants; and

17 WHEREAS, the City of Riverside (“City”) desires to establish a Beverage Container
18 Recycling City/County Payment Program in accordance with CalRecycle’s Program and also desires
19 to extend the City Manager’s authority to include the authority to apply for and secure the available
20 funds on behalf of the City available under CalRecycle’s Beverage Container Recycling City/County
21 Payment Program, and carryout all other purposes in the application process administered by
22 CalRecycle, and such authority shall be valid from the date of adoption of this Resolution up to and
23 including June 29, 2018.

24 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
25 California, as follows:

26 Section 1: The City Council of the City of Riverside does hereby authorize application to
27 CalRecycle for a Beverage Container Recycling City/County Payment Program.

1 Section 2: The City Manager, or its designee, is hereby authorized and empowered to
2 execute on behalf of the City all necessary documents, including but not limited to applications,
3 payment requests, agreements and amendments thereto, necessary to secure grant funds and to
4 implement the approved grant project.

5 Section 3: The authority granted herein shall be valid until June 29, 2018.
