HOMELESS POINT-IN-TIME (PIT) COUNT

- Count of unsheltered and unsheltered people experiencing homelessness on a single-night in January
- U.S. Department of Housing & Urban Development requires Continuum of Cares (CoC) to conduct an annual count of people experiencing homelessness who are in shelter, transitional housing, and safe havens on a single night every other year
- Planned, coordinated and carried out locally
- Housing Inventory Count: PIT inventory of provider programs within a CoC that provide beds and units to serve people experiencing homelessness

RIVERSIDE COUNTY PIT COUNT

- Each year, the Riverside County CoC partners with cities to facilitate mandated count of people experiencing homelessness throughout the County.
- Data is used to demonstrate the need for federal and state funding, service and resources planning, and to inform the community about homelessness.
- 2021 PIT Count was cancelled due to the COVID-19 pandemic.

2022 RIVERSIDE COUNTY PIT COUNT

- September 23, 2021: County held its first planning meeting with key leaders, stakeholders, service providers, law enforcement and nonprofit agencies.
- Discussions included outreach and strategic engagement strategies, location mapping, mobile survey development and identification of deployment sites.
