<u>ISSUANCE OF REQUEST FOR PROPOSALS SEEKING MIXED-USE RETAIL AND MULTI-FAMILY PROJECT - SUCCESSOR AGENCY-OWNED AND HOUSING AUTHORITY-OWNED LAND - 2731-2871 UNIVERSITY AND 2882 MISSION INN AVENUES</u>

Following discussion, it was moved by Chair Fierro and seconded by Member Hemenway to recommend that this matter be submitted to City Council to decide on issuance of a Request for Proposal or exclusive negotiation with Grapevine Economic Development Fund, Inc., for the development of the Successor Agency-owned land, located at 2731-2871 University Avenue and Housing Authority-owned land of approximately 0.22 acres located at 2882 Mission Inn Avenue. The motion carried unanimously.
