

**FIRST AMENDMENT TO MASTER AGREEMENT
FOR WEED ABATEMENT WORK
AT VARIOUS LOCATIONS THROUGHOUT THE CITY
ON AN AS-NEEDED BASIS**

THIS FIRST AMENDMENT TO MASTER AGREEMENT FOR WEED ABATEMENT WORK AT VARIOUS LOCATIONS THROUGHOUT CITY ON AN AS NEEDED BASIS ("First Amendment"), is made and entered into this ____ day of _____, 2020, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City") and J. OROZCO ENTERPRISES INC., a California corporation, doing business as OROZCO LANDSCAPE AND TREE COMPANY ("Contractor"), with respect to the following facts:

RECITALS

WHEREAS, on or about July 5, 2017, City and Contractor entered into the Master Agreement for Weed Abatement Work at Various Locations Throughout City ("Agreement"); and

WHEREAS, the Agreement will expire on June 30, 2020, but may be extended for a period of three (3) additional years; and

WHEREAS, City and Contractor desire to extend the term of the Agreement by three (3) years, to June 30, 2023, and to increase the "Authorized Not to Exceed Amount" by Three Hundred Thousand Dollars (\$300,000), for a total amount of Six Hundred Thousand Dollars (\$600,000).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. The term of the Agreement is hereby extended by three (3) years, to June 30, 2023.
2. Paragraph 8.1, Contract Price, is hereby amended to increase the "Authorized Not to Exceed Amount" to Six Hundred Thousand Dollars (\$600,000).
3. All terms and conditions of the Agreement not inconsistent with this First Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
