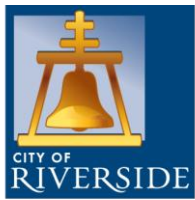
The minutes of September 24, 2025, were approved as presented.

#### THE 2025 RACIAL IDENTITY PROFILING DATA REVIEW

Tracy and the option of using Commission's subpoena powers to obtain the records.

Following discussion, Community Police Review Commission will hold reviewing stage 4 OID 022-00362 and #MB22 019 0001 – J. Tracy, until after the case goes to trial. Moved by Commissioner Teichert and seconded by Commissioner Lundy. The motion carried with Vice Chair Gutierrez absent.

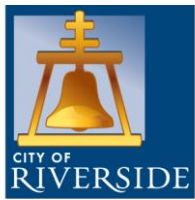
### CLOSED SESSION
