

**SECOND AMENDMENT
TO SERVICES AGREEMENT**

**INNOVATIVE DESIGN AND SHEET METAL PRODUCTS, INC.,
DOING BUSINESS AS
INNOVATIVE EMERGENCY EQUIPMENT**

THIS SECOND AMENDMENT TO SERVICES AGREEMENT ("Second Amendment") is made and entered into this 6TH day of June, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and INNOVATIVE DESIGN AND SHEET METAL PRODUCTS, INC., doing business as INNOVATIVE EMERGENCY EQUIPMENT, a Delaware Corporation authorized to do business in California ("Contractor"), with respect to the following:

RECITALS

WHEREAS, on or about July 27, 2021, City and Contractor entered into that certain Services Agreement for Police Vehicles Equipment, Installation and Removal Services.

WHEREAS, on or about May 19, 2022, City and Contractor entered into that certain First Amendment to Services Agreement for Police Vehicles Equipment, Installation and Removal Services to increase the compensation.

WHEREAS, City and Contractor would like to further increase the annual compensation by an additional One Hundred Fifty Thousand Dollars (\$150,000) annually for the term ending September 30, 2024.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Company agree as follows:

1. Section 3, Compensation is amended to increase the annual compensation by an additional One Hundred Fifty Thousand Dollars (\$150,000) for a revised total of Five Hundred Fifty Thousand Dollars (\$550,000), annually for the term ending September 30, 2024, for a total contact amount not to exceed One Million Seven Hundred Thousand Dollars (\$1,700,000).

2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.


