COMMUNICATIONS

UPDATES ON CONFERENCES, SEMINARS AND REGIONAL MEETINGS ATTENDED BY COMMISSIONERS

Chair Krick shared that he enjoyed the Commission trip to Gable Farms that occurred on November 16th, 2024.

Commissioner Tarmo thanked Commissioner Krick and Commissioner Lee for their help at the Riverside Airport's Trunk or Treat Event on October 19th. Commissioner Tarmo expressed her enjoyment of the event.

Commissioner Mickelson discussed a concern she had with the Riverside County's Office on Aging on how their phone calls are being routed. She also discussed how the 988 Suicide and Crisis Lifeline phone number can help people with mental illness and families that have difficult times during the holiday season. She attended a State event - Transforming California's Behavioral Health System (Prop 1 and CARE Act) which addressed people with severe mental illness.

Commissioner Lee gave a presentation on the "Yes to More Life Program" he is involved with to Amelia Earhart Middle School on November 12th. On Tuesday, November 19th "Mark From Riverside" presented a video on Commissioner Lee's "Yes to More Life" program on TikTok.

Commissioner Trimm discussed Michael's Place, a bakery and café that focuses on training and employing individuals with intellectual disabilities. She also attended an Inland Empire Disability Employment Business Roundtable to discuss working towards getting the private sector more involved with getting more employment for individuals with disabilities in Riverside.
