

NOTICE OF PUBLIC HEARING ISSUANCE OF RIVERSIDE PUBLIC FINANCING **AUTHORITY LEASE REVENUE BONDS**

NOTICE IS HEREBY GIVEN that a public hearing will be held on September 17, 2024, at 3:00 p.m., or as soon thereafter as such matter can be heard, at a regular meeting of the City Council of the City of Riverside in the Art Pick Council Chamber located at 3900 Main Street, Riverside, California 92522, the City Council of the City of Riverside will conduct a hearing regarding the issuance by the Riverside Public Financing Authority (the "Authority") of one or more series of Lease Revenue Bonds in a not-to-exceed amount of \$73,000,000 (the "Bonds") in order to finance the costs of the acquisition, construction, installation, furnishing and equipping of certain capital improvements, including, but not limited to, renovations to a museum and related improvements, to be owned and operated by the City of Riverside and to provide funds to refund the Authority's outstanding Lease Revenue Refunding Bonds, Series 2012A. Lease payments securing the Bonds will be payable from the City's General Fund, subject to abatement as set forth in the Lease Agreement, as supplemented by the First Supplement to Lease Agreement and Second Supplement to Lease Agreement, each by and between the Authority and the City of Riverside.
