### PUBLIC HEARINGS

PLANNING CASE - DP-2022-00047 (COA), DP-2022-00048 (EIR) - 5229 Arlington Avenue, WARD 3

Proposal by Jamie Chapman of Riverside Property Owner, LLC to consider the following entitlements for a mixed-use development consisting of 388 multi-family residential units, and 25,320 square feet of commercial space: 1) A Certificate of Appropriateness for the demolition of the former 192,139 square foot Sears building and all appurtenances; and 2) An Environmental Impact Report, with respect to Cultural Resources. The Board disclosed any substantive communications outside of the notice public hearing. Scott Watson, Historic Preservation Officer presented the staff report. Jim Ivory of Foulger Pratt presented the applicant presentation and stated they were in agreement with the recommended conditions of approval. There was 1 Public Comment. The public hearing was closed.

Discussion included concerns about the adaptive reuse in the analysis and alternatives, the architectural design of the Aldi building as it relates to the project, the orientation of the commercial structure facing the parking lot rather than Arlington, and the historic impact to Ward 3 due to the demolition. Board members also acknowledged the developer's efforts to address CHB comments in the revised architectural design. Some members indicated that the EIR alternatives and analysis was reasonable; however, while there are significant and unavoidable impacts in the EIR, Council has the authority to consider the project benefits versus impacts. Following discussion, it was moved by Vice-Chair McDoniel and seconded by Chair Gamble to find Planning Case DP-2023-00047
